

Management Discussion and Analysis

管理層討論及分析

Hans Energy Company Limited (the "Company") and its subsidiaries (the "Group") is a leading operator in providing integrated facilities of jetties, storage tanks, warehousing and logistic services in south China for petroleum and liquid chemicals products, offering value-added services in its own ports and storage tank farms (the "terminal storage business"), trading of oil and petrochemical products (the "trading business") and operating of a filling station (the "retail business").

漢思能源有限公司(「本公司」)及其附屬公司(「本集團」)為能源行業之主要營運商,於華南地區提供石油及液體化學產品之綜合碼頭港口、貯存罐及倉儲物流服務,並於其自有港口及貯存罐區提供增值服務(「碼頭倉儲業務」)、買賣油品及石化產品(「貿易業務」)及經營加油站(「零售業務」)。



BUSINESS REVIEW

Terminal Storage Business

The Group owns and operates a liquid product terminal, namely Dongzhou Petrochemical Terminal ("DZIT") carried out by Dongguan Dongzhou International Petrochemical Storage Limited ("DZ International"), an indirect subsidiary of the Company. DZIT is situated in Lisha Island, Humen Harbour district, Shatian county, Dongguan city, Guangdong province, with a site area of approximately 516,000 square metres. It was built with berths ranging from 500 to 100,000 dwt and is installed with 94 oil and petrochemical tanks of a total storage capacity of approximately 260,000 cubic metres, out of which 180,000 cubic metres are specialised for gasoline, diesel and similar petroleum products commonly available in trading and consumption markets. Storage tanks with capacity of 80,000 cubic metres were built for petrochemical products. In addition, the Group has reserved approximately 150,000 square meters of land for the construction of various storage facilities in the future.

Strategic Location

The liquid product terminal of the Group is located in the Greater Bay Area. As Guangdong province is the pioneer in economic development of China and our terminal situates in the centre of the economic circle of the province, such location edge attracts customers to engage with our terminal for their distribution of refined oils. Apart from oil products customers, there are customers who have manufacturing plants in the Greater Bay Area. In their business cycle, there are requirements to temporarily store their dangerous, poisonous and hazardous goods in designated controlled facilities with proper licences in accordance with governmental regulations for safety and environment reasons. The customers may store their hazardous raw materials, work-in-progress and finished goods in our storage facilities. Our terminal employs experienced, professional and skillful management teams with well-equipped features storage hardware. The Group persistently maintain high standards in safety and environment protection. Our terminal is fully and properly licensed to handle wide range of dangerous and hazardous goods. They provide convenience to our customers to move their products in and out of the terminal during their production cycle.

業務回顧

碼頭倉儲業務

本集團擁有及經營液體產品碼頭,即由本公司間接附屬公司東莞市東洲國際石化倉儲有限公司(「東洲國際」)經營的東洲國際碼頭(「東洲石化庫」)。東洲石化庫位處廣東省東莞市沙田鎮虎門港區立沙島,佔地約516,000平方米,建有可容納介乎500至100,000噸級泊位,裝備94台油品及石化產品貯存罐,總庫容為約260,000立方米,其中180,000立方米專門用於汽油、上地及於貿易及消費市場常見類似之石油產品。80,000立方米的貯存罐建作石化產品之用。此外,本集團預留約150,000平方米土地,用於未來建設各類倉儲設備。

策略位置

本集團液體產品碼頭位於大灣區。由於廣 東省乃中國經濟發展先驅,加上我們的碼 頭位於省內經濟圈中心,該地區優勢吸引 了客戶駐於我們碼頭進行成品油分銷活 動。除石油產品客戶外,我們亦有在大灣 區設廠的製造業客戶。在彼業務週期內, 由於安全及環保因素,彼等需在根據政府 法規持有合適執照的指定受監控設施內臨 時儲存危險、有毒及有害的貨物。客戶可 在我們的倉庫設施內儲存其危險性的原 料、半成品及成品。我們的碼頭聘有經驗 豐富、專業及技術嫻熟的管理團隊,並配 備設施功能齊全的倉儲硬件。本集團一直 維持高水平的安全環保標準。我們的碼頭 均領有全面及妥當的執照,可處理大部份 危險有害的貨物,方便客戶於生產週期內 搬運產品進出庫區。

Revenue

The terminals earn storage income by leasing their storage tanks to customers based on the storage tank size and category engaged. Apart from this, they collect handling charges when providing services in moving cargoes in and out from the terminals for customers, either by water in the jetties or by road from the loading stations. Furthermore, the terminals provide ancillary services such as tank cleaning and waste treatment to customers and earn respective fees for the services rendered.

Key Performance Indicators

The leaseout rates and cargo throughput are the major key performance indicators of the terminals. Assume that the unit rate remains the same, higher leaseout rate should return with higher storage income. More cargoes flows mean more works in the terminals thus more handling fee income. The leaseout rates and cargo throughput of DZIT during the last two years are as follows:

The major operational statistics of DZIT in 2021 declined were mainly affected by the impact of the consumption tax on some oil and petrochemical products and the pressure of the relocation of factories by the customers. Despite that the Group introduced some high-quality new customers in some local state-owned enterprises at the beginning of the year which mainly store refined oil products and pick up cargos by vessels that drove the number of domestic vessels visited increased by 53.5% as compared to last year, China government began to levy consumption tax on some products during the year, that resulted in the reduction in the number of trucks served to pick up cargoes. Coupled with certain customers plan to relocate factories and reduce the production, the Group's overall transshipment volume and terminal throughput decreased by 58.7% and 11.7% respectively as compared to the last year. During the year, the average leaseout rate for both oil and petrochemical tanks maintain was 97.8%, representing a slight decrease of 0.7 percentage points over the last year.

Trading Business

The Group operates in trading of oil and petrochemical products carried out in the People's Republic of China (the "PRC") and Hong Kong. Shanghai Diyou Industry Co., Ltd. ("SHDY"), an indirect subsidiary of the Company, is principally engaged in trading of oil and petrochemical products and holds a refined oil wholesale operating licence issued by the Ministry of Commerce of the PRC and is also a qualified supplier for major energy companies such as CNOOC, Sinopec etc. Besides, SHDY actively develops and expands the end customers of filling stations and provides petrol and diesel supplies to third party filling stations during the year. The Group has further expanded the trading business carried out by the Group's subsidiary in Hong Kong to increase the Group's customer base and business scale during the year.

The operational statistics of trading business during the last two years are as follows:

During the year, China government began to levy consumption tax on some refined oil products such as light cycle oil, mixed aromatics and diluted asphalt, which hindered the Group's expansion of light cycle oil trade business. In addition, as China strengthened the supervision of taxation on the upstream and downstream distribution of refined oil products, the market price became more transparent and the price difference between the north and the south shrank. As a result, SHDY reduced its back-to-back orders considerably during the year, leading to a decrease of over 25% and 50% in the number of sales contracts entered into and sales volume respectively during the year. In order to improve unit profit and minimize the impact of the consumption tax on the sale volumes, the Group changed its business strategies, and vigorously expanded and developed the end customers of filling stations, which not only facilitated SHDY's business operations to bring into play the advantages of centralised procurement, reduced procurement cost and gained stable profit through the way of centralised procurement, retail and wholesale, but also helped to enhance the market risk resistance and obtain higher profit by leveraging on market price fluctuation. Besides, the Group actively expanded its import trade to drive the trading business carried out by the Group's subsidiary in Hong Kong. During the year, the Group entered into 93 sales contracts with a total sales volume of approximately 447,000 metric ton.

Retail Business

The Group owns a filling station which was situated in Zengcheng district, Guangzhou city, the PRC with a site area of approximately 12,500 square metres. Its floor area, fuel island configuration, equipment level and construction standards all meet the standards of local flagship filling stations. The filling station has commenced its operations since April 2020 and in order improve the operational efficiency, during the year was leased out to an independent third party by the Group for rental income. The Group actively expands its share of the refined oil retail market by increasing its business segments through various means, including but not limited to leasing, signing of key fuel supply agreement and providing brand management services. Currently, there are eight filling stations under the brand "Hans Energy" located across Guangdong Province and Guangxi Province in the PRC.

年內,中國政府對輕質循環油、混合芳 烴、稀釋瀝青等部分成品油產品開始徵收 消費税,導致本集團拓展的輕質循環油貿 易業務受阻。加上中國加強對成品油產品 上下游流通環節的税收監管,使市場價格 愈加透明,南北價差收縮,令上海迪友於 年內減少不少背靠背訂單,導致年內訂立 的銷售合同數目及銷量分別減少超過25% 及50%。為提高單位利潤以及減少消費税 對銷量的影響,本集團改變經營策略,大 力開拓及發展加油站終端客戶,這不但有 利於上海迪友營運業務發揮集中採購的優 勢,降低採購成本,通過集中採購、零售 及批發的方式獲得穩定的利潤,而且有助 提高市場抗風險能力,利用市場價格波動 獲得更高的收益。除此之外,本集團積極 拓展進口貿易,帶動本集團香港附屬公司 的貿易業務。年內,本集團共簽訂93份銷 售合同,總銷量約為447,000公噸。

零售業務

本集團擁有一所加油站,該加油站位處中國廣州市增城區,佔地約12,500平方米。其佔地面積、加油島設置、設備水平及設標準等各方面均達到本地區旗艦加加湖於二零年四月開始,為提高營運效益,年內本集團積極強力。本集團積極擴大成品油零一名獨立第三方經營,以收期,透過不同形式。以與加州,透過不同形式,包括但不限品,的份額,透過可能,以增加其業務板塊。目前「漢思能源」品牌加油站數目已達八家,份中國廣東省及廣西省。

During the year ended 31 December 2021, the Group's total revenue decreased from \$2,481.9 million to \$1,972.4 million, a decrease by 20.5% as compared to the last year. During the year, total revenue from sales of oil and petrochemical products was \$1,791.1 million, accounting for 90.8% of the Group's total revenue, decreased by 22.1% as compared to the last year. The decrease was mainly attributable to the decrease in the number of sales contracts entered and sale volume in SHDY as a result from the consumption tax on some refined oil products imposed by China government at the beginning of the year. During the year, revenue from the provision of terminal, storage and transshipment activities for liquid chemicals products in DZIT was \$168.0 million, a slightly increase by 2.2% on a year basis. The increase was mainly attributable to the appreciation of average exchange rate in Renminbi yuan ("RMB") during the year. Excluding the appreciation effect, revenue from the provision of terminal, storage and transshipment activities for liquid chemicals products in DZIT decreased by about 4.7% during the year. The decrease was mainly attributable to the impact of the consumption tax on some oil and petrochemical products by China government and the relocation factories by some customers that reduced the Group's overall transshipment volume and terminal throughput during the year. Revenue from operating a filling station decreased from \$18.4 million to \$13.3 million, a decrease by 27.7% on a year basis. The decrease was mainly attributable that the Group leased out the filling station to an independent third party for rental income from August 2021, resulting that retail revenue from operating a filling station only accounted for seven months during the year.

截至二零二一年十二月三十一日止年度, 本集團總收入由24.819億元下跌至19.724 億元,較去年減少20.5%。年內,總銷售 油品及石化產品的收入為17.911億元, 佔本集團總收入的90.8%,較去年減少 22.1%。下跌主要由於中國政府於年初對 部份成品油產品開徵消費税,致上海迪友 訂立的銷售合同數目及銷量減少。年內, 東洲石化庫就提供液體化學品之碼頭、貯 存以及轉輸業務的收入為1.680億元,按 年微增2.2%。增加乃主要由於年內人民 幣(「人民幣」)平均匯率升值。撇除升值的 影響,東洲石化庫就提供液體化學品的碼 頭、貯存以及轉輸業務收入於年內下跌約 4.7%。收入減少主要是由於中國政府對部 分油品及石化產品徵收消費稅所帶來的影 響,以及若干客戶搬遷廠房,減少了本集 團年內的整體轉輸量及碼頭吞吐量。經營 加油站的收入由1,840萬元減少至1,330萬 元,按年減少27.7%。減少主要由於本集 團從二零二一年八月起把加油站租予一名 獨立第三方經營,以收取租金收入,導致 年內來自經營加油站的零售收入僅佔七個 月。

OUTLOOK

The Group's overall operating profit continued to improve in 2021. While operating income maintained its growth, net assets of the Company increased significantly as a result of appreciation of financial investments. This reflects that the Group's diversification has begun to play a positive role. On this basis, it is expected that the Group will achieve better operating results and greater profitability in the coming year.

Actively promoting new terminal storage construction projects

In 2022, the Dongzhou Petrochemical storage facilities will continue to maintain a high leaseout rate to ensure the continued stability and growth of revenue from the terminal storage business. The new structure of project companies and the shareholding allocation plan have been agreed with corresponding parties for the second phase of the Dongzhou Petrochemical project in 2021, namely, the construction of liquefied natural gas ("LNG") contingency peak adjustment storage, gasification and transmission facilities on the existing reserve land and corresponding modifications to ancillary facilities to the terminal. We are now making the every effort to push the process of the project approval works from the local government to complete as soon as possible. Since the handling and storage charges for LNG and other liquefied gases are several times higher than those for oil and liquid chemicals, the completion of this project will significantly increase the revenue and profitability of Dongzhou Petrochemical.

Continuing to develop the trading and retail business

In 2021, the international trading business operated by the Group's Hong Kong subsidiary commenced, which compensated for the decline in trading volume of the domestic refined oil products due to the influence of China's policies and market price fluctuations, leading to an increase in the overall trading volume and gross profit of the Group. In 2022, the Group will continue to expand its scale of operation by exploring new trading customers and product categories. For the filling station business, the Group adjusted its business model by leasing out its self-operated filling station assets to an independent third party, which freed itself from the tedious daily management and operation of the retail segment, and focused on expanding its market share through the signing of fuel supply agreements and providing brand licensing franchises. Through this approach, the number of franchised filling stations under the brand "Hans Energy" reached eight as of the end of 2021. In 2022, the Group will continue to sign new franchising agreements to expand its share in the refined oil retail market.

展望

二零二一年本集團整體經營溢利繼續保持增長的同時,金融投資增值帶來的公司資產淨值顯著增加。反映出本集團開展多元化經營的優勢開始發揮積極作用。在這個基礎上,可以預見本集團在新的一年將取得更好的經營業績和更大的收益。

積極推進新的碼頭倉儲建設項目

二零二二年東洲石化倉儲設施將持續維持高出租率,保證碼頭及倉儲業務收入繼續穩定和增長。二零二一年東洲石化二期建設項目(即在現有儲備土地建設液化天然氣(「LNG」)應急調峰庫、氣化及轉輸設施及相應的碼頭配套改造)已與各合作方完成了項目公司架構及股權分配方案的談項事出工作儘早完成。由於LNG等液化氣體裝出工作儘早完成。由於LNG等液化氣體裝卸及倉儲收費是數倍於油品和液體化工品,這一項目建設完成後,將大幅度提升東洲石化的收入和盈利。

繼續開拓貿易及零售業務

二零二一年,本集團香港附屬公司開展的 國際貿易開始起步,彌補了國內成品油貿 易受到中國政策影響及市場價格波動造成 的數量有所下降的缺口,帶動本集團整體 貿易數量及毛利均有增長。二零二二年將 在去年的基礎上,繼續開拓新的貿易客戶 及品種,繼續擴大經營規模。在加油站業 務方面,本集團調整了業務模式,將自營 的加油站資產出租予獨立第三方經營,使 集團從零售業繁瑣的日常管理和經營中解 脱出來,並通過簽訂供油協議及品牌授權 的加盟方式,集中精力擴大市場份額。截 至於二零二一年底止,通過這種方式,「漢 思能源」品牌的加盟油站已經達到八家。二 零二二年本集團仍會繼續簽約新的加盟油 站,擴大成品油零售市場份額。

New energy industry is an important investment direction for the Group

At the end of 2021, the Group completed the Tranche 1 subscription of the shares in Bravo Transport Holdings Limited ("BTHL"), the parent company of New World First Bus Services Limited ("NWFB") and Citybus Limited ("Citybus"). The Tranche 2 Completion took place on 28 March 2022, and immediately after the Tranche 2 Completion, the Group acquired a total of 7% of the entire issued share capital of BTHL. Thereafter, the Group holds approximately 15.56% of the entire issued share capital of BTHL. The principal considerations for the increased investment in BTHL are as follows: on the one hand, the bus companies are good investment targets because of their stable cash income and huge appreciation potential. On the other hand, to act in concert with the HKSAR government's goal of achieving carbon neutrality, NWFB and Citybus propose to develop hydrogen fuel cell buses plan. This is highly consistent with the strategic intent underlying one of Hans Energy's future development directions of exploring new energies (especially hydrogen energy) supply chain related business, which will enable realization of mutual benefits and synergized development. In 2022, the Group will increase its research and investment in the hydrogen energy supply chain field and strive to screen out hydrogen energy supply and storage projects that can be used in Hong Kong, and provide fuel supply solutions for the introduction and promotion of the use of hydrogen fuel cell buses and other hydrogen fuel vehicles in Hong Kong, thereby contributing to the achievement of the goal of "Carbon Neutral" in Hong Kong.

新能源產業是集團未來重要的投資方向

二零二一年底,本集團完成第一批增持 新世界第一巴士服務有限公司(「新巴」) 及城巴有限公司(「城巴」)的母公司Bravo Transport Holdings Limited(「BTHL」)公司股 份,第二批於二零二二年三月二十八日完 成,緊隨第二批完成後,本集團合共增持 BTHL全部已發行股本的7%,此後,本集 團持有BTHL全部已發行股本約15.56%。 增加對BTHL投資的主要考慮如下:一方面 是因為巴士公司有穩定現金收入以及巨大 的升值潛力,是良好的投資對象;另一方 面新巴城巴,配合香港特區政府實現[碳中 和]的目標,提出發展氫能源巴士的計劃, 這與漢思能源將發展新能源特別是氫能供 應鏈相關業務作為未來發展方向之一的戰 略意圖高度一致,可實現相互促進,同步 發展的效益。二零二二年本集團將加大氫 能源供應鏈方面的研究和投入,爭取篩選 出可立足香港本地的氫能供應及儲運項 目,為香港引進和推廣使用氫能燃料電池 巴士車及其他氫能車輛提供燃料供應解決 方案,為香港實現「碳中和」目標盡一份責 任。

Revenue and gross profit margin

During the year, the Group's revenue was approximately \$1,972.4 million (2020: \$2,481.9 million), representing a decrease of 20.5% over the last year. The decrease was mainly attributable to the decrease in revenue from sale of oil and petrochemical products carried out by SHDY by 22.3% over the last year. During the year, total revenue from trading of oil and petrochemical products was \$1,791.1 million, accounting for 90.8% of the Group's total revenue. During the year, the gross profit was approximately \$104.4 million (2020: \$66.4 million), an increase of 57.3% over the last year and gross profit margin was 5.3%, increased by 2.6 percentage points on a yearly basis. The increase was attributable to the increase of trading activities to the end customers of filling stations with higher gross profit margin.

收入及毛利率

年內,本集團的收入約為19.724億元(二零二零年:24.819億元),較去年下跌20.5%。下跌主要由於上海廸友經營的油品及石化產品的銷售收入較去年下跌22.3%。年內,油品及石化產品貿易的總收入為17.911億元,佔本集團總收入的90.8%。年內,毛利約為1.044億元(二零二零年:6,640萬元),較去年增加57.3%,毛利率為5.3%,按年增加2.6個百分點。增長的原因乃主要由於毛利率較高的加油站終端客戶的貿易活動增加所致。

Direct costs and operating expenses

During the year, the Group's direct costs and operating expenses were approximately \$1,867.9 million (2020: \$2,415.5 million), representing a decrease of 22.7% over the last year, of which cost of inventories from oil and petrochemical products were \$1,759.5 million (2020: \$2,309.3 million), accounting for 94.2% of total direct costs and operating expenses. The decrease of direct costs and operating expenses was consistent to the decrease of revenue during the year.

EBIT and EBITDA

During the year, the Group's EBIT was approximately \$46.8 million (2020: \$11.6 million), increased by 304.9% over the last year. The increase was mainly attributable to the increase in net fair value gains on financial assets at fair value through profit or loss ("FVPL") by approximately \$73.4 million, and increase of gross profit by approximately \$38.0 million offset by the increase in loss allowance of trade and other receivables of approximately \$13.7 million and increase of equity settled share-based payment expenses by approximately \$56.0 million. As a result of the increase of EBIT, EDITDA also increased to \$123.0 million (2020: \$85.9 million) for the year, increased by 43.3% over the last year.

Finance costs

During the year, finance costs amounted to \$54.9 million (2020: \$49.9 million) which were mainly incurred on the Group's outstanding bank loans. The increase was mainly attributable to the increase of bank borrowing interest rate during the year and the appreciation of average exchange rate in RMB as compare to last year.

Taxation

The provision for Hong Kong Profits Tax for the year ended 31 December 2021 is calculated at 16.5% of the estimated assessable profits of the year, except for one subsidiary of the Group which is a qualifying corporation under the two-tiered Profits Tax rate regime. No Hong Kong Profits Tax was provided for the year ended 31 December 2020 as the Group sustained a loss for Hong Kong Profits Tax purposes for the year. The applicable tax rate of the Group's PRC subsidiaries for the year ended 31 December 2021 was 25% (2020: 25%).

Basic and diluted losses per share

During the year ended 31 December 2021, the basic and diluted loss per share was \$0.41 cents (2020: \$1.07 cents).

直接成本及經營開支

年內,本集團的直接成本及經營開支約為 18.679億元(二零二零年:24.155億元), 較去年減少22.7%:當中油品及石化產品 的庫存成本為17.595億元(二零二零年: 23.093億元),佔直接成本及經營開支總額 94.2%。直接成本及經營開支的減少與年 內收入的減少相符。

EBIT及EBITDA

年內,本集團EBIT約為4,680萬元(二零二零年:1,160萬元),較去年增加304.9%。增加主要由於按公允值計入損益(「按公允計入損益」)之金融資產公允值收益淨額增加約7,340萬元及毛利增加約3,800萬元,抵銷了貿易應收賬款及其他應收款項之虧損撥備增加約1,370萬元及權益結算的股份支付費用增加約5,600萬元。由於EBIT增加,年內EDITDA亦增加至1.23億元(二零二零年:8,590萬元),較去年增加43.3%。

財務成本

年內,財務成本為5,490萬元(二零二零年:4,990萬元),此乃主要是來自本集團之未償還銀行貸款。增長的主要原因為年內銀行借款利率的提高及人民幣平均匯率較去年有所升值。

税項

截至二零二一年十二月三十一日止年度的香港利得税撥備乃按該年度的估計應課税溢利的16.5%計算,惟本集團的一間附屬公司為兩級利得稅稅制下的合資格公司除外。截至二零二零年十二月三十一日止年度,就香港利得稅而言,由於本集團於年內產生虧損,因此並無就香港利得稅計提撥備。截至二零二一年十二月三十一日止年度,本集團的中國附屬公司的適用稅率為25%(二零二零年:25%)。

每股基本及攤薄虧損

截至二零二一年十二月三十一日止年度, 每股基本及攤薄虧損為0.41仙(二零二零年:1.07仙)。

LIQUIDITY, GEARING AND CAPITAL STRUCTURE

As at 31 December 2021, the Group's total cash and cash equivalents amounted to approximately \$118.2 million (2020: \$353.2 million). Most of the funds were held in HK dollars, RMB and US dollars.

As at 31 December 2021, the Group had total assets of approximately \$2,286.7 million (2020: \$2,020.5 million) and net current assets of approximately \$354.3 million (2020: \$665.4 million). The change was mainly attributable to the subscription of shares in BTHL with an amount of \$244.6 million settled by cash and bank balances, the net fair value gains on financial assets at FVPL approximately \$70.0 million and the fair value gains on unlisted equity securities at fair value through other comprehensive income approximately \$309.3 million during the year. The current ratio as at 31 December 2021 of the Group was 2.02 (2020: 2.75). The change was mainly attributable to the decrease in cash and bank balances and the increase in short-term bank borrowing.

As at 31 December 2021, the Group had outstanding bank borrowings of \$768.2 million (2020: \$789.8 million). The total equity of the Group as at 31 December 2021 amounted to approximately \$1,352.4 million (2020: \$986.2 million). The increase was mainly attributable to the increase of investment revaluation reserve by approximately \$309.3 million. The gearing ratio (defined as total liabilities to total assets) as at 31 December 2021 was 40.9% (2020: 51.2%). The Group will continuously consider various financial methods to improve our existing financial position and reduce the degree of leverage of the Group.

FINANCIAL RESOURCES

During the year ended 31 December 2021, the Group met its working capital requirement principally from its business operation and financed with facilities provided by bank. Management is confident that the Group should have adequate financial resources to meet its future debt repayment and support its working capital and future expansion requirements. Due attention will be paid to the capital and debt markets as well as the latest developments of the Group in order to ensure the efficient use of financial resources.

流動資金、資本負債比率及資本結構

於二零二一年十二月三十一日,本集團的 現金及現金等值項目總額約為1.182億元 (二零二零年:3.532億元)。大部分資金以 港元、人民幣及美元持有。

於二零二一年十二月三十一日,本集團的資產總值約為22.867億元(二零二零年:20.205億元),而流動資產淨值約為3.543億元(二零二零年:6.654億元)。變動主要由於年內以現金及銀行結餘認購BTHL的股份,金額為2.446億元、按公允值計入損益之金融資產公允值收益淨額約7,000萬元,以及按公允值計入其他全面收益之非上市股本證券公允值收益約3.093億元所致。本集團於二零二一年十二月三十一日的流動比率為2.02(二零二零年:2.75)。變動主要由於現金及銀行結餘減少以及短期銀行借款增加所致。

於二零二一年十二月三十一日,本集團的未償付銀行借款為7.682億元(二零二零年:7.898億元)。本集團於二零二一年十二月三十一日的權益總額約為13.524億元(二零二零年:9.862億元)。增加主要由於投資重估儲備增加約3.093億元所致。於二零二一年十二月三十一日的資本負債比率(定義為按負債總額除以資產總額)為40.9%(二零二零年:51.2%)。本集團將繼續考慮不同融資方法,以改善現有財務狀況及降低本集團的槓桿水平。

財務資源

截至二零二一年十二月三十一日止年度,本集團主要通過其業務營運滿足營運資金需求,並以銀行提供的融資撥付資金。管理層有信心,本集團應有充足的財務資源償還日後債務,並支持其營運資金及日後擴展需求。本集團將小心注意資本市場及債務市場的狀況以及本集團最新發展之情況,從而確保善用財務資源。

SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSALS AND FUTURE PLANS FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS

(i) Subscription of shares in Bravo Transport Holdings Limited

Reference is made to the announcement of the Company dated 21 August 2020 in relation to, among others, the previous subscription of shareholding interests in Bravo Transport Holdings Limited ("BTHL") by Templewater Bravo Holdings Limited ("TWB Holdings"), Glorify Group Limited ("Glorify") (a wholly-owned subsidiary of the Company) and Ascendal Bravo Limited ("ABL") pursuant to the BTHL Share Subscription Agreement. Following the completion of the issue of such BTHL Shares pursuant to the BTHL Share Subscription Agreement and as at the date hereof, BTHL is held as to approximately 90.85%, approximately 8.56% and approximately 0.59% by TWB Holdings, Glorify and ABL, respectively.

On 3 December 2021, Glorify entered into the Sale and Purchase Agreement with TWB Holdings and ABL, pursuant to which Glorify has conditionally agreed to acquire, and TWB Holdings and ABL have conditionally agreed to sell, an aggregate of 700 BTHL Shares, being 695 BTHL Shares from TWB Holdings and 5 BTHL Shares from ABL, respectively and together representing 7% of the entire issued share capital of BTHL at the total consideration of \$350,000,000 (equivalent to US\$44,929,397).

Upon Tranche 1 Completion, BTHL will be owned as to approximately 85.99%, approximately 13.45% and approximately 0.56% by TWB Holdings, Glorify and ABL, respectively. Upon Tranche 2 Completion, BTHL will be held as to approximately 83.90%, approximately 15.56% and approximately 0.54% by TWB Holdings, Glorify and ABL, respectively.

Tranche 1 and the Tranche 2 Completion took place on 8 December 2021 and 28 March 2022, respectively and all the conditions precedent for Tranche 1 Completion and Tranche 2 Completion were fulfilled. As at 31 December 2021, Glorify holds 1,344.91 BTHL Shares, representing approximately 13.45% of the entire issued share capital in BTHL. As at the date of this annual report, Glorify holds 1,555.91 BTHL Shares, representing approximately 15.56% of the entire issued share capital in BTHL.

Further details of the aforementioned transaction are set out in the announcements of the Company dated 3 December 2021 and 28 March 2022.

(i) 認購Bravo Transport Holdings Limited股份

茲提述本公司日期為二零二零年八月二十一日的公告,內容有關(其中包括)由Templewater Bravo Holdings Limited(「TWB Holdings」)、本公司全資附屬公司Glorify Group Limited(「Glorify」)及Ascendal Bravo Limited(「ABL」)根據Bravo Transport Holdings Limited(「BTHL」)股份認購協議對BTHL股權作出的先前認購事項。根據BTHL股份認購協議完成發行該等BTHL股份後,BTHL分別由TWB Holdings、Glorify及ABL持有約90.85%、約8.56%及約0.59%。

於二零二一年十二月三日,Glorify與TWB Holdings及ABL訂立買賣協議,據此Glorify已同意有條件收購,而TWB Holdings及ABL已同意有條件出售合共700股BTHL股份,即TWB Holdings的695股BTHL股份及ABL的5股BTHL股份,合共佔BTHL全部已發行股本的7%,總代價為350,000,000元(相當於44,929,397美元)。

第一批完成後,BTHL將分別由 TWB Holdings、Glorify及ABL擁有約 85.99%、約13.45%及約0.56%。 第二批完成後,BTHL將分別由 TWB Holdings、Glorify及ABL擁有約 83.90%、約15.56%及約0.54%。

第一批完成及第二批完成分別於二零二一年十二月八日及二零二二年三月二十八日落實,而第一批完成及第二批完成的所有先決條件已獲達成。於二零二一年十二月三十一日,Glorify持有1,344.91股BTHL股份,佔BTHL全部已發行股本約13.45%。於本年報日期,Glorify持有1,555.91股BTHL股份,佔BTHL全部已發行股本約15.56%。

上述交易的進一步詳情載於本公司日 期為二零二一年十二月三日及二零 二二年三月二十八日的公告。

(ii) Provision of financial assistance

Pursuant to the BTHL Shareholders' Agreement, each of Glorify and ABL has agreed to pledge 51% of the BTHL Shares held by each of them from time to time, to TWB Holdings as a back-to-back arrangement for TWB Holdings' granting of a share charge over a total of 5,100 BTHL Shares held by TWB Holdings in favour of the vendor under the acquisition agreement referred to in the announcement of the Company dated 21 August 2020.

Accordingly, upon each of Tranche 1 Completion and Tranche 2 Completion, Glorify shall deposit with TWB Holdings, share certificates representing 51% of the Sale Shares acquired by Glorify at each of Tranche 1 Completion and Tranche 2 Completion, for the purpose of topping up Glorify's obligations to pledge 51% of the BTHL Shares held by it.

(iii) Subscription of limited partnership interest

As at 31 December 2021, total capital contribution into the limited partnership was approximately \$22 million (equivalent to approximately US\$2.8 million) as set out in note 32 to the financial statements.

Save for those disclosed in this annual report, there was no other significant investments, nor there was no any other material acquisitions or disposals during the year. The Group did not have any future plans for materials investments nor addition of capital assets as at the reporting date.

(ii) 提供財政援助

根據BTHL股東協議,Glorify及ABL各自已同意將彼等不時各自所持的BTHL股份的51%質押予TWB Holdings,作為TWB Holdings根據本公司日期為二零二零年八月二十一日的公告所述的收購協議以賣方作為受益人,授出由TWB Holdings持有合共5,100股BTHL股份的股份質押之背對背安排。

因此,於各第一批完成及第二批完成時,Glorify應向TWB Holdings於各第一批完成及第二批完成時存放相當於Glorify所收購銷售股份51%的股票,為了補足Glorify質押其所持有BTHL股份的51%的責任。

(iii) 認購有限合夥公司權益

誠如財務報表附註32所載,於二零二一年十二月三十一日,向有限合夥公司的注資總額約為2,200萬元(相當於約280萬美元)。

除本年報所披露外,年內概無其他重要投資,亦無任何其他重大收購或出售事項。 本集團於報告日期並無任何重大投資或添 置資本資產的未來計劃。

EXPOSURE TO FLUCTUATION IN EXCHANGE RATES AND PRICES AND RELATED HEDGE

The Group's cash and cash equivalents are held predominately in HK dollars, RMB and US dollars. Operating outgoings incurred by the Group's subsidiaries in the PRC are mainly denominated in RMB, which usually receives revenue in RMB as well. Management considers that the Group exposed to fluctuation in exchange rates are not significant. Prices of oil products are affected by a wide range of global and domestic factors which are beyond the control of the Group. The fluctuations in such prices may have favourable or unfavourable impacts on the Group. However, the Group mainly operated on a back-to-back sale and purchase model and has been vigorously developing the establishment of end customers of filling stations (including branded filling stations) to reduce procurement costs by centralising procurement, retail and wholesale, which not only prevents risk of oil price fluctuations but also enhances profitability. Accordingly, management is in the opinion that the Group's exposure to foreign exchange rate and price risks are not significant, and hedging by means of derivative instruments is considered unnecessary.

Save for the above disclosed, there was no other significant risks of exchange rates and price during the year ended 31 December 2021.

EMPLOYEE AND REMUNERATION POLICY

As at 31 December 2021, the Group had a total of approximately 230 employees (2020: 230), 187 (2020: 205) of which worked for the terminals. The Group remunerates its employees based on industry practices and individual performance and experience. Every year, the Group devises a budget which states total salary and bonus plan for the year to encourage the Group's employees to contribute their best efforts and to make maximum economic benefits to the Group. In accordance with the relevant government regulations in the PRC, the Group is required to cover social insurance, including but not limited to retirement, medical, workman compensation and unemployment insurance as well as housing fund for every qualified employee in the PRC. With these insurance policies and staff benefits, the Group hopes to provide a reasonable welfare for each qualified employee. On top of the basic remuneration, discretionary award or bonus (in cash or other forms in kind) as may be determined by the Board may be granted to selected employees by reference to the Group's as well as individual's performances. Details are set out in the section of "Directors' Report" under the paragraph headed "Share Option Scheme" and "Share Award Scheme".

EXECUTIVE DIRECTORS

Mr. David An, aged 62, has been the Chairman and an executive Director of the Company since July 2002. He has many years of experience in China business particularly in the provision trading of petroleum products and petrochemicals, properties investments and developments in China.

Mr. Yang Dong, aged 61, has been an executive Director and the Chief Executive Officer of the Company since July 2016. Mr. Yang joined the Company in 2012. Prior to that, he held various senior key positions in the subsidiaries of China Petroleum & Chemical Corporation such as the deputy general manager in China Petrochemical International Co. Ltd. and deputy chairman and executive director in Sinopec Kantons Holdings Limited (Stock code: 934), the securities of which is listed on The Stock Exchange of Hong Kong Limited ("Stock Exchange"). He has extensive experience in international trade of petroleum and chemical commodities. Mr. Yang graduated from Beijing Normal University with a degree in Economics. He also holds a Master's degree in Project Management from University of Management and Technology.

Mr. Zhang Lei, aged 56, has been an executive Director of the Company since August 2007. Mr. Zhang joined the Company as Chief Operating Officer, PRC in 2006. He has many years of experience in petroleum and petrochemical industry. He has expertise in petrochemical specialized technology and is familiar with financial accounting policy and system of the PRC. Mr. Zhang also has in-depth knowledge in large petrochemical project management. He had held various key positions such as the chief financial officer of the Singapore branch, deputy general manager and chief financial officer of the Hong Kong branch of China Petrochemical Corporation. Mr. Li had worked for Henderson Land Development Company Limited. He was a chief financial officer of GDH Limited and Guangdong Holdings Limited until 31 December 2019, an executive director and company secretary of Guangdong Land Holdings Limited (stock code: 124) until 20 February 2020 and a non-executive director of Guangdong Investment Limited (stock code: 270) until 28 March 2020, the securities of which are listed on the Stock Exchange. Apart from the abovementioned, Mr. Li is the standing committee member of Chinese People's Political Consultative Conference Guangdong Provincial Committee, and an advisor of Management Accounting of Ministry of Finance, the PRC from April 2021.

The Board reserves for its decisions all major matters of the Company, including: approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those may involve conflict of interests), financial information, appointment of Directors and other significant financial and operational matters.

All Directors have full and timely access to all relevant information as well as the advice and services of the company secretary of the Company (the "Company Secretary"), with a view to ensuring that Board procedures and all applicable rules and regulations are followed.

Each Director is normally able to seek independent professional advice in appropriate circumstances at the Company's expense, upon making request to the Board.

Pursuant to Rule 3.10(1) of the Listing Rules, every board of directors of a listed issuer must include at least three INEDs. Pursuant to Rule 3.11 of the Listing Rules, the issuer shall appoint a sufficient number of INEDs to meet the minimum number required under Rule 3.10(1) and Rule 3.10A of the Listing Rules within three months after failing to meet the requirements. Pursuant to Rule 3.21 of the Listing Rules, the audit committee shall comprise non-executive directors only and must comprise a minimum of three members.

Following the resignation of Mr. Woo King Hang on 22 December 2021, the Board comprises five members, including three executive Directors and two INEDs. This falls below the minimum number of INEDs and members of the Audit Committee requirement under Rules 3.10(1) and 3.21 of the Listing Rules.

Following the appointment of Mr. Chung Chak Man, William as an INED and a member of each of the Audit Committee, Nomination Committee and Remuneration Committee with effect from 15 March 2022, the Board has six directors, three of whom are INEDs. Accordingly, the Company is in compliance with the requirements of Rule 3.10(1) and Rule 3.10A of the Listing Rules. The Audit Committee comprises three members, all of whom are INEDs. Accordingly, the Company is in compliance with the requirements of Rule 3.21 of the Listing Rules.

The INEDs bring a wide range of business and financial expertise, experiences and independent judgement to the Board. Through active participation in Board meetings, taking the lead in managing issues involving potential conflict of interests and serving on Board committees, all INEDs make various contributions to the effective direction of the Company.

The Company has received written annual confirmation from each INED in respect of his independence pursuant to the independence guidelines set out in Rule 3.13 of the Listing Rules. The Company has assessed his independence and concluded that all INEDs are independent within the definition of the Listing Rules.

Appointment and Succession Planning of Directors

The Company has established formal, considered and transparent procedures for the appointment and succession planning of Directors.

Each of the INEDs has entered into an appointment letter with the Company for a term of three years from their date of appointment.

Pursuant to the Company's memorandum and article of association, all Directors are subject to retirement by rotation at least once every three years at the Company's general meeting and any Directors appointed by the Board to fill a casual vacancy or as an addition to the Board shall hold office only until the next following annual general meeting after his/her appointment and be subject to reelection at such meeting.

Pursuant to Article 116 of the Company's memorandum and articles of association, Mr. Zhang Lei and Mr. Chan Chun Wai, Tony shall retire by rotation and being eligible, offer themselves for re-election at the forthcoming annual general meeting.

Pursuant to Article 99 of the Company's memorandum and articles of association, Mr. Chung Chak Man, William shall hold office until the forthcoming annual general meeting, and being eligible, offer himself for re-election.

根據本公司組織章程大綱及細則第99條, 鍾澤文先生將留任至即將舉行之股東週年 大會,並符合資格且願意於會上膺選連任。

Continuous Professional Development of Directors

Every newly appointed Director will receive comprehensive, formal and tailored induction on the first occasion of his/her appointment, so as to ensure that he/she has appropriate understanding of the business and operations of the Company and that he/she is fully aware of his/her responsibilities and obligations under the Listing Rules and relevant regulatory requirements.

Directors should participate in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. Reading material on relevant topics will be issued to Directors where appropriate. All Directors are encouraged to attend relevant training courses at the Company's expenses.

Directors confirmed that they have complied with the Code Provision C.1.4 on Directors' training. During the year, all Directors attended seminars and training sessions arranged by various professional institutes and bodies. In addition, relevant reading materials including the updates on the business, operations, corporate governance, legal and regulatory matters have been provided to all Directors for their reference and studying.

Notices of regular Board meetings are served to all Directors at least 14 days before the meetings. For other Board and committee meetings, reasonable notice is generally given.

Agenda and Board papers together with all appropriate, complete and reliable information are sent to all Directors at least 3 days before each Board meeting or committee meeting to keep the Directors apprised of the latest developments and financial position of the Company and to enable them to make informed decisions. The Board and each Director also have separate and independent access to the senior executives whenever necessary.

Company Secretary is responsible to take and keep minutes of all Board meetings and committee meetings. Draft minutes are normally circulated to Directors for comment within a reasonable time after each meeting and the final version is open for Directors' inspection.

According to current Board practice, any material transaction, which involves a conflict of interests for a substantial shareholder or a Director, will be considered and dealt with by the Board at a duly convened Board meeting. The Company's memorandum and articles of association also contain provisions requiring Directors to abstain from voting and not to be counted in the quorum at meetings for approving transactions in which such Directors or any of their associates have a material interest.

Company Secretary

Ms. Lam Lai Wan, Bondie is the Company Secretary. According to Rule 3.29 of the Listing Rules, she has taken no less than 15 hours of relevant professional training during the year ended 31 December 2021. Board Diversity Policy

The Board adopted the board diversity policy (the "Diversity Policy") on 29 August 2013.

All Board appointments will be based on merits, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board. Selection of candidates for Board membership will be based on a range of diversity perspectives, including but not limited to gender, age, experience, cultural and educational background, expertise, skills and know-how.

The Nomination Committee will review the Diversity Policy, as appropriate, to ensure the effectiveness of such policy.

As at the date of this annual report, the Board comprises six Directors, of which three of them are INEDs.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Code Provision C.2.1 stipulates that the roles of the Chairman and Chief Executive Officer (the "CEO") should be separate and should not be performed by the same individual.

The Company complies with the Code Provision C.2.1, the positions of the Chairman and CEO are segregated and are held by Mr. David An and Mr. Yang Dong respectively. These positions have clearly defined separate responsibilities. Mr. David An will focus on the overall strategic planning and business development of the Group, whereas Mr. Yang Dong will be responsible for the overall management, administrative functions and day-to-day business operations of the Group.

The Company regularly reviews its corporate governance practices to ensure that these continue to meet the requirements of the CG Code.

BOARD COMMITTEES

The Board has established three committees, namely, the Nomination Committee, Remuneration Committee and Audit Committee, for overseeing particular aspects of the Company's affairs. All Board committees of the Company are established with defined written terms of reference. The terms of reference of the Board committees are posted on the Company's website and Hong Kong Exchanges and Clearing Limited's website and are available to shareholders upon request.

The Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expenses.

Nomination Committee

As at the date of the annual report, the Nomination Committee comprised three INEDs, namely Mr. Chan Chun Wai, Tony (Chairman of the Nomination Committee), Mr. Li Wai Keung and Mr. Chung Chak Man, William.

The principal duties of the Nomination Committee include reviewing the structure, size and composition of the Board, making recommendations to the Board on the appointment and succession planning of Directors, and assessment of the independence of the INEDs.

The Nomination Committee will reference to the Board nomination policy (the "Nomination Policy") adopted by the Group on 21 December 2018 for selecting and recommending candidates for directorships.

Selection Criteria

The Nomination Committee will evaluate, select and recommend candidate(s) for directorships to the Board by giving due consideration to criteria, having due regard to the benefits of diversity on the Board, including but not limited to gender, age, experience, cultural and educational background, expertise, skills and know-how, sufficient time to effectively carry out their duties, their services on other listed and non-listed companies should be limited to reasonable numbers, qualifications including accomplishment and experience in the relevant industries the Company's business is involved in, independence, reputation for integrity, potential contributions that the individual(s) can bring to the Board and commitment to enhance and maximise shareholders' value.

董事委員會

提名委員會之主要職責,包括檢討董事會 之架構、人數及組成、就董事之委任及接 任計劃向董事會提出推薦意見,以及評估 獨立非執行董事之獨立性。

提名委員會會參考本集團於二零一八年 十二月二十一日採納的董事提名政策(「提 名政策」)以甄選及提名董事候選人。

甄選準則

提名委員會將依據準則,充分考慮多元化 對董事會的裨益作評估、篩選及推薦董事人選,其中包括但不限於性別、 齡、經驗、文化及教育背景、專長、技能 及專門知識方面的多樣化、有充足時間以 有效履行其職責,彼等於其他上市及非上 市公司的服務應限於合理數目、資歷,包 括在本公司業務所涉相關行業的成績事會 作出的潛在貢獻及承諾提升及最大化股東 價值。

Nomination Process

The Nomination Committee will recommend to the Board for the appointment of a Director in accordance with the following procedures and process:

- (a) By giving due consideration to the current composition and size
 of the Board, develop a list of desirable skills, perspectives and
 experience at the outset to focus the search effort;
- (b) To consult any source it deems appropriate in identifying or selecting suitable candidates, such as referrals from existing directors, advertising, recommendations from an independent agency firm and proposals from shareholders of the Company with due consideration given to the criteria;
- (c) To adopt any process it deems appropriate in evaluating the suitability of the candidates, such as interviews, background checks, presentations and third-party reference checks;
- (d) Upon considering a candidate suitable for the directorship, the Nomination Committee will hold a meeting and/or by way of written resolutions to, if thought fit, approve the recommendation to the Board for appointment;
- (e) To make the recommendation to the Board in relation to the proposed appointment and the proposed remuneration package;
- (f) The Board will have the final authority on determining the selection of nominees;
- (g) In order to be eligible to be elected as Director at any general meeting, the candidate should be recommended by the Board; or a notice in writing by a member of the Company given his intention to propose such candidate, and also a notice in writing by the candidate of his willingness to be elected; and
- (h) In the context of re-appointment of retiring Directors by giving due consideration to the overall contribution and service to the Company of the retiring Director(s) including the attendance of Board meetings and, where applicable, general meetings, and the level of participation and performance on the Board; and whether the retiring Director(s) continue(s) to satisfy the criteria, thereafter recommend retiring Director(s) to the Board for re-appointment. The Nomination Committee and/or the Board shall then make recommendation to shareholders in respect of the proposed re-election of Director(s) at the general meeting.

- (h) 如重新委任退任董事,則會適當考慮 退任董事對本公司的整體貢獻及服 務,包括其出席董事會會議及(如適 當)股東大會的情況以及在董事中 的參與程度及表現;及退任董事是否 繼續符合準則,其後向董事會推薦其 續聘。提名委員會及/或董事會須於 股東大會上向股東推薦董事的建議膺 選連任。

Remuneration Committee

The primary objectives of the Remuneration Committee include reviewing and making recommendations to the Board on the remuneration packages and the remuneration policy and structure for all individual Directors and senior management; and establishing transparent procedures for developing such remuneration policy and structure to ensure that no Director or any of his associates will participate in deciding his/her own remuneration, which remuneration will be determined by reference to the performance of the individual and the Company as well as market practice and conditions.

The human resources department is responsible for collection and administration of the human resources data and making recommendations to the Remuneration Committee for consideration. The Remuneration Committee consults the Chairman and/or the CEO about these recommendations on remuneration policy, structure and remuneration packages.

The Remuneration Committee met once during the year ended 31 December 2021 to review and make recommendations to the Board on the remuneration packages of the executive Directors during the year ended 31 December 2021.

Audit Committee

All of them possess the appropriate professional qualifications or accounting or related financial management expertise. None of the members of the Audit Committee is a former partner of the Company's existing external auditors.

The main duties of the Audit Committee include the following:

- (a) To review the financial statements and reports and consider any significant or unusual items before submission to the Board;
- (b) To review the relationship with the external auditors by reference to the work performed by the auditors, their fees and terms of engagement, and make recommendation to the Board on the appointment, reappointment and removal of external auditors;
- (c) To review the Company's financial reporting system, risk management and internal control systems;
- (d) To review the effectiveness of the Company's risk management and internal control measures, including the functions of account and financial reporting, reviewing the adequacy of the Group's human resources, staff qualifications and experiences, training programmes and budget of the Company's accounting and financial reporting functions; and
- (e) To review arrangements by which employees of the Company may, in confidence, raise concerns about possible improprieties in financial reporting, internal control or other matters.

The Audit Committee is provided with sufficient resources to discharge its duties and has access to independent professional advice if considers necessary.

The Audit Committee held three meetings during the year ended 31 December 2021 to (i) review audited annual financial results for the year ended 31 December 2020 and unaudited interim financial results for the six months ended 30 June 2021; (ii) review financial reporting, risk management and internal control and compliance procedures; and (iii) review the scope of work and make recommendations on the appointment of the auditors of the Company.

There is no material uncertainty relating to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern.

Risk Management and Internal Controls

Responsibility

The Company has maintained an internal control system and its implementation has been considered effective by the Audit Committee and the Board. In addition, the Audit Committee has communicated with external auditors of the Company to understand if there is any material control deficiency. Nevertheless, the Company will review the need for an internal audit function on an annual basis.

The Board is responsible for maintaining an adequate risk management and internal control system and has overall responsibility for reviewing and maintaining an adequate and effective risk management and internal control systems to safeguard the interests of the shareholders and the assets of the Company and reviewing its effectiveness on an annual basis.

The Company has maintained a tailored governance structure with defined lines of responsibility and appropriate delegation of responsibility and authority to the senior management.

Risk Management and Internal Control Framework

The Group's risk management framework adopts an integrated bottom-up and top-down risk review process. The top-down risk review process covers overseeing, identification, assessment and mitigation of risk at corporate level while the bottom-up risk review process covers identification, assessment and mitigation of risk at business unit level and across functional areas. The integrated risk review process is to enable comprehensive identification and prioritization of all material risks throughout the Group, escalation of material risks at the right managerial level, effective risk dialogue among the management, and proper oversight of risk mitigation efforts.

Pursuant to Article 72 of the Company's memorandum and articles of association, general meetings shall be convened on the written requisition of any two or more members of the Company deposited at the principal place of business of the Company in Hong Kong or, in the event that the Company ceases to have such a principal place of business, the registered office specifying the objects of the meeting and signed by the requisitionists, provided that such requisitionists held as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company.

If the Board does not within 21 days from the date of deposit of the requisition proceed duly to convene the meeting, the requisitionists themselves or any of them representing more than one-half of the total voting rights of all of them, may convene the extraordinary general meeting in the same manner, as nearly as possible, as that in which meetings may be convened by the Board provided that any meeting so convened shall not be held after the expiration of three months from the date of deposit of the requisition, and all reasonable expenses incurred by the requisitionists as a result of the failure of the Board shall be reimbursed to them by the Company.

Putting Forward Proposals at General Meetings

There are no provisions in the Company's memorandum and articles of association or the Cayman Islands Companies Law for shareholders to move new resolutions at general meetings. Shareholders who wish to move a resolution may request the Company to convene a general meeting in accordance with the procedures set out in the preceding paragraph.

As regards proposing a person for election as a Director, please refer to the procedures posted on the Company's website.

Putting Forward Enquiries to the Board

For putting forward any enquiries to the Board, shareholders may send written enquiries to the Company.

Note: The Company will not normally deal with verbal or anonymous enquiries.

In order to enable the continuity of the share option scheme of the Company, the Board proposes to adopt a new share option scheme (the "2022 Share Option Scheme") subject to the approval of the Company's shareholders in the forthcoming 2022 annual general meeting. Details of the 2022 Share Option Scheme are set out in the circular enclosed with this annual report to be despatched to the shareholders.

The summary of the 2012 Share Option Scheme is stated as follows:

1. Purpose:

The purpose of the 2012 Share Option Scheme is to enable the Company to recruit and retain high-caliber employees and attract resources that are available to the Group and to provide the Company with a means of giving incentive to, rewarding, remunerating, compensating and/or providing benefits to such persons who contribute or may bring benefit to the Group.

2. Participants:

Under the 2012 Share Option Scheme, the Board may at their discretion grant options to any eligible participant including any employee, Director, consultant, advisor, agent, business affiliate, business partner, joint venture partner, strategic partner, or any supplier or provider of goods or services to the Company or any subsidiaries of the Company from time to time to subscribe for the shares of the Company (the "shares").

3. Total number of shares available for issue under the 2012 Share Option Scheme and percentage of issued share capital:

The maximum number of shares with respect to which options may be granted under the 2012 Share Option Scheme and any other schemes shall not, in aggregate, exceed 10% of the issued share capital of the Company on the date of adopting the 2012 Share Option Scheme. The limit may be refreshed at any time by obtaining approval of the shareholders of the Company in a general meeting from time to time, provided that the new limit must not be in aggregate exceed 10% of the issued share capital of the Company as at the date of the relevant shareholders' approval in general meeting. However, the maximum number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the 2012 Share Option Scheme and any other scheme of the Company must not in aggregate exceed 30% of the issued shares from time to time.

On 30 August 2018, the Company had granted 127,500,000 options carrying the rights to subscribe for an aggregate of 127,500,000 shares, of which 3,000,000 options had been lapsed, 2,000,000 options had been forfeited, 49,000,000 options have been exercised by the relevant grantees on 30 October 2020 respectively, with 73,500,000 options remain outstanding.

On 23 December 2020, the Company granted 5,000,000 options carrying the rights to subscribe for 5,000,000 shares to Mr. Zhang Lei ("Mr. Zhang"), an executive Director and 243,763,800 options carrying the rights to subscribe for 243,763,800 shares to Mr. An, the chairman of the Board, an executive Director and a substantial shareholder of the Company. The said grant of options to Mr. An was subject to the approval by the independent shareholders at the EGM. Upon the completion of the grant of the options to and acceptance thereof by the grantees, the Company had utilised 100% of the maximum number of shares which may be issued upon exercise of all options were to be granted under the 2012 Share Option Scheme. Accordingly, the Company sought the approval by its shareholders for the refreshment of the 2012 Share Option Scheme mandate limit (the "Scheme Mandate Limit"). At the EGM held on 25 January 2021, the independent shareholders of the Company passed the resolution to approve the said grant of options to Mr. An and the shareholders of the Company passed the resolution to approve the refreshment of the Scheme Mandate Limit.

The said grant of options to Mr. An was subject to the independent shareholders' approval at the AGM. Upon the completion of the said grant of the options to and acceptance thereof by the grantees, the Company had further utilised 100% of the shares which may be issued upon exercise of all options to be granted under the 2012 Share Option Scheme pursuant to the refreshment of the Scheme Mandate Limit at the EGM. As such, the Company has sought the approval by its independent shareholders for the refreshment of the Scheme Mandate Limit. At the AGM held on 2 June 2021, the independent shareholders passed the resolutions to approve the said grant of options to Mr. An, and the independent shareholders of the Company passed the resolution to approve the refreshment of the Scheme Mandate Limit.

Options may be exercised at any time from date of grant of the share option to the 10th anniversary of the date of grant as may be determined by the Directors.

7. The amount payable on application or acceptance of the option and the period within which payments of calls must or may be made or loans for such purpose must be paid:

Options granted must be taken up within 21 days of the date of grant, upon payment of HK\$1 per option.

8. The basis of determining the exercise price:

The exercise price is determined by the Directors, provided that it shall be at least the higher of (i) the closing price per share as stated in the daily quotation sheets of the Stock Exchange on the date of the grant of the share options; (ii) the average closing price per share as stated in the daily quotation sheets of the Stock Exchange for the five business days immediately preceding the date of the grant of the options; and (iii) the nominal value of a share.

9. The remaining life:

The 2012 Share Option Scheme remains in force for a period of 10 years from adoption of such scheme and expires on 27 December 2022.

The Board may engage one or more trustees in the process of granting, administrating and/or vesting any awards, and the Board may at its discretion delegate such powers and/or functions relating to the administration of the Share Award Scheme to the trustee as the Board thinks fit

4. Duration:

The Share Award Scheme will terminate on the 10th anniversary of the Adoption Date or such earlier date as the Board may determine.

5. Maximum limits:

The number of shares which may be held by the trust at any one time (taken together with all unvested awarded shares granted under the Scheme Rules) shall not be more than 5% of total numbers of issued shares (i.e. 197,831,900 shares) at the date of grant of the award.

6. Operation:

The Board may, from time to time remit funds to the trustee for the purposes of the Share Award Scheme, and such money will form part of the trust fund. The Board may instruct the trustee to purchase the number of shares underlying the award from the open market (either on-market or off-market) and the trustee shall hold such shares on trust for the participants until they are vested in accordance with the Scheme Rules.

7. Vesting:

The Board has a discretion to determine the terms of the award, including the grantor of the award, the number of shares subject to the award, the vesting conditions, the date when the award will vest, and whether the award will carry rights to dividends paid between the date of the award and the vesting date.

As at 31 December 2021, the number of the Company's shares held for the purpose of the Share Award Scheme was 58,590,000 (2020: 58,590,000 shares).

On 6 January 2022, the trustee purchased a total number of 20,000,000 shares of the Company on the market at a total consideration of approximately HK\$3,234,000 for the purpose of the Share Award Scheme. As at the date of this annual report, a total number of 78,590,000 shares of the Company was held by the trustee and no grant of awards has been made under the Share Award Scheme. Further details of the share purchase pursuant to Share Award Scheme are set out in the announcement of the Company dated 6 January 2022.

3. 管理:

The percentage of the aggregate purchases attributable to the Group's five largest suppliers comprised approximately 88.2% (2020: approximately 44.3%) of the Group's total purchases and the percentage of the purchases attributable to the Group's largest supplier were approximately 33.6% (2020: approximately 12.7%) of the Group's total purchases.

Saved as disclosed above, none of the Directors, their close associates or any shareholder which, to the knowledge of the Directors, owned more than 5% of the Company's issued share capital had any interest in the share capital of any of the five largest customers or suppliers of the Group.

The Group have evaluated the materiality and importance in ESG aspects through the following steps:

本集團已透過以下步驟評估環境、社會及 管治方面的重大性及重要性:

Step 1: Identification - Industry Benchmarking

- Relevant ESG areas were identified through the review of relevant ESG reports of the local and international industry peers.
- The materiality of each ESG areas was determined based on the importance of each ESG area to the Group through internal discussion of the management and the recommendation of ESG Reporting Guide (Appendix 27 of the Listing Rules).

Step 2: Prioritization - Stakeholder Engagement

 The Group discussed with key stakeholders on key ESG areas identified above to ensure all the key aspects to be covered.

Step 3: Validation - Determining Material Issues

 Based on the discussion with key stakeholders and internal discussion among the management, the Group's management ensured all the key and material ESG areas, which were important to the business development, were reported and in compliance with ESG Reporting Guide.

As a result of this process carried out in 2021, those important ESG areas to the Group were discussed in this Report.

ESG GOVERNANCE

Board's oversight of ESG issues

Board's overall vision and strategy in managing ESG issues

The board of directors ("Board") has a primary role in overseeing the management of the Group's sustainability issues. During the year, the Board spent significant time in evaluating the impact of ESG-related risks on our operation and formulating relevant policy in dealing with the risks. The oversight of the Board is to ensure the management to have all the right tools and resources to oversee the ESG issues in the context of strategy and long-term value creation.

• 根據與主要權益人的討論以及管理層 之間的內部討論,本集團的管理層確 保所有對業務發展至關重要的關鍵及 重大環境、社會及管治範疇已予以報 告並遵守環境、社會及管治報告指 引。

由於在二零二一年進行該程序,因此本報告中已討論該等對本集團具重要性的環境、社會及管治範疇。

環境、社會及管治治理

董事會對環境、社會及管治事宜的督導

董事會在管理環境、社會及管治事宜上的 總體願景及策略

董事會(「董事會」)在督導本集團可持續發展事宜的管理方面擔當主要角色。年內,董事會耗費大量時間評估環境、社會及管治相關風險對本集團營運的影響,並制定相關政策以處理該等風險。董事會的督導是為了確保管理層擁有一切合適的工具及資源,以便在策略和長期價值創造下督導環境、社會及管治事宜。

ESG working group

The Group attaches great importance to ESG work. Under the leadership of the Board of the Company, each subsidiary has set up a dedicated safety and environmental protection department ("ESG Working Group") to implement specific safety and environmental protection work, so as to comply with government requirements, implement the concept of "safety and environmental protection" in its operation and fulfil its social responsibilities.

The ESG Working Group is primarily responsible for reviewing and supervising the ESG process, and risk management of the Group. Different ESG issues were reviewed by the Working Group at the meeting, which holds once per year. During the reporting period, the ESG Working Group and the management reviewed the ESG governance and different ESG issues.

Board's ESG management approach and strategy for material ESG-related issues

In order to better understand the opinions and expectations of different stakeholders on our ESG issues, materiality assessment is conducted each year. We ensure various platforms and channels of communication are used to reach, listen and respond to our key stakeholders. Through general communication with stakeholders, the Group understands the expectations and concerns from stakeholders. The feedbacks obtained allow the Group to make more informed decisions, and to better assess and manage the resulting impact.

The Group has evaluated the materiality and importance in ESG aspects through the steps: (1) material ESG area identification by industry benchmarking; (2) key ESG area prioritization with stakeholder engagement; and (3) validation and determining material ESG issues based on results of communication among stakeholders and the management. Hence, this can enhance understanding of their degree and change of attention to each significant ESG issue, and can enable us to more comprehensively plan our sustainable development work in the future. Those important and material ESG areas identified during our material assessment were discussed in this Report.

環境、社會及管治工作小組

本集團十分重視環境、社會及管治工作。 在本公司董事會的領導下,各附屬公司都 設立專責安全環保部門(「環境、社會及管 治工作小組」)專責落實安全及環保具體工 作,以配合政府要求,在經營中貫徹落實 「安全環保」理念,履行社會責任。

環境、社會及管治工作小組主要負責檢討和監督本集團的環境、社會及管治流程和風險管理。工作小組每年召開一次會議,檢討不同的環境、社會及管治事宜。於報告期間,環境、社會及管治工作小組及管理層檢討環境、社會及管治治理和不同的環境、社會及管治事宜。

董事會的環境、社會及管治管理方針和對 重大環境、社會及管治相關事宜的策略

為更好地了解不同權益人對我們的環境、 社會及管治事宜的意見和期望,我們每年 進行重大性評估。我們確保利用各種溝通 平台和管道來接觸、聆聽及回應主要權益 人。通過與權益人的一般溝通,本集團可 了解權益人的期望和關注。獲得的回饋意 見讓本集團能做出更明智的決定,並更好 地評估及管理由此產生的影響。

A. ENVIRONMENTAL ASPECTS

Based on ISO14001, the standard of management system for environment, the Group has established a set of management systems regarding environmental protection, including but not limited to "Atmosphere Pollution Management System", "Waste Management System" and "Wastewater Management System".

The Group's objectives on environmental protection are to eliminate and reduce the impact of its operation on the ecological environment and endeavours to save resources and protect the environment. The Group is in strict compliance with the "Environmental Protection Law of the People's Republic of China" and other relevant laws and regulations, and had no material non-compliance regarding environmental issues during the reporting period.

A1. EMISSIONS

Air Pollutants Emission

Emission control is essential for mitigating the impact on the environment and protecting the health of employees. The Group's emission complies with "Emission Limits of Air Pollutants (DB44/27-2001)" (大氣污染物排放限值) and "Emission Standard of Air Pollutant for Bulk Gasoline Terminal (GB 20950-2007)" (儲油庫大氣污染物排放標準). The decrease in air pollutants emission in 2021 was mainly attributable to less frequent business travels and transportation by vehicles, the use of gasoline recovery device, the volatilized gasoline was collected, resulting in the decrease in pollutants emission as well as effective implementation of fuel saving strategies by our terminals during the year. Furthermore, the Group targets to reduce the emission of air pollutants by 10% by 2025. The air pollutants emission during the reporting period is as follows:

A. 環境層面

根據ISO14001(環境管理體系標準), 本集團已建立一套環保管理系統,包 括但不限於「大氣污染管理系統」、 「廢棄物管理系統」及「污水管理系統」。

本集團的環保目標是消除及減低其營 運對生態環境的影響,並盡力節約資 源及保護環境。本集團嚴格遵守《中 華人民共和國環境保護法》及其他相 關法例及法規,於報告期間並無有關 環境事宜的重大不合規。

A1. 排放物

大氣污染物排放

控制排放對減低對環境的影響及保障僱員健康至關重要。本集團的排放物符合「大氣污染物排放限值(DB44/27-2001)」及「儲油庫大氣污染物排放標準(GB 20950-2007)」。二零二一年大氣污染物排放量減少乃主要由於年內使用汽車的商務差旅和交通行程較不頻繁,碼頭倉儲業務啟用了油之一次,為對方,以及碼頭有效實施節治氣少失物排放,以及碼頭有效實施節治氣少,以及碼頭有效實施節。此外,本集團以二零二五年前減少10%的大氣污染物排放的情況如下:

As most of the products stored are highly volatile, the Group has implemented "VOCs One Enterprise One Policy Comprehensive Improvement Program" (VOCs 一企一策綜合整治方案) to control volatile organic compounds (VOCs) emission from source and production processes. Key measures to mitigate the leakage of the volatile chemicals are implemented as follows:

- External floating roof tanks¹ are used to store gasoline, diesel and other volatile chemical products.
- Nitrogen blanketing² is used in the tanks to ensure stored product is separated from the air, vapour generated in the tank is collected and treated with activated carbon.
- To reduce the non-methane hydrocarbon (NMHC) emission, oil-gas condensation recovery devices are installed to achieve a recycling rate of 98%.
- All the volatile organic compounds (e.g., gasoline, alkane solvents) are stored in specific containers and sealed properly to avoid leakage.
- Using gasoline recovery device to collect volatilized gasoline, the recovery ratio is over 95%, in order to reduce air pollutants emission.

Apart from measures adopted to reduce VOCs, the Group lowers the emission of SO_2 by using low-sulfur diesel (National VI standard) for the boiler.

由於大部分儲存產品均非常容易揮發,本集團已實施「VOCs一企一策綜合整治方案」,從源頭及生產過程控制易揮發有機化合物(VOCs)的排放。減低易揮發化學品洩漏的關鍵措施實行如下:

- 使用浮頂式貯存罐¹儲存汽油、 柴油及其他易揮發化學品。
- 在貯存罐使用氮封裝置²,確保儲存產品與空氣隔絕,收集貯存罐內產生的蒸氣及以活性碳處理。
- 為減少非甲烷碳氫化合物排放, 安裝油汽冷凝回收裝置,達到 98%回收率。
- 所有易揮發有機化合物(如汽油、烷烴溶劑)儲存於特定儲存器及妥善密封以避免洩漏。
- 使用油氣回收裝置將揮發的油氣 收集,油氣回收率達95%以上, 以減少大氣污染物排放。

除採取減低易揮發有機化合物的措施 外,本集團透過於鍋爐使用低硫柴油 (國家第六期標準)以減低二氧化硫的 排放。

- ¹ External floating roof tanks (浮頂式儲存罐) are storage tanks commonly used to store large quantities of petroleum products.
 - They eliminate breathing losses and greatly reduce the evaporative loss of the stored liquid.
- ² Nitrogen blanketing (氮封裝置) is widely used in many industries to prevent fires, explosion, degradation of products during their production, storage and transportation.

Greenhouse Gas ("GHG") Emission³

Climate change is gradually concerned by the community. The Group manages the carbon neutral by minimising the energy consumption and water consumptions as these activities cause significant emission of greenhouse gas. Policies and procedures adopted on resources saving are mentioned in the section "Use of resources". With a sense of promoting the use of clean energy and green environment, the Group has switched its fuel consumption to fossil fuel with lower carbon content such as Liquefied Petroleum Gas ("LPG"). The decrease in GHG scope 1 emission in 2021 was mainly due to the reduction in business travels and transportation by vehicles, as well as effective implementation of fuel saving strategies by our terminals during the year. In light of the increase in the usage of boiler for terminal storage business, leading to increase in consumption of low-sulfur diesel, the GHG scope 2 emission increased in 2021. The Group will strive to reduce the emission of GHG by 10% by 2025.

The GHG emission during the reporting period is as follows:

Hazardous and Non-hazardous Wastes

Wastes generated are handled with a comprehensive procedure to mitigate the impact to the environment. The Group has a strict classification system for different types of wastes. Each type of waste has specific storage location and collection procedures. There is a precaution implemented for the leakage of waste to prevent pollution.

Hazardous wastes such as hazardous wastewater, waste oil cleaning rag and organic solvents are handled according to the latest policies of "National Hazardous Waste Inventory". These wastes are separately stored and handled with ledger for record. The Group engages qualified recycling companies to perform waste disposal and treatment so as to minimise the impact on the environment.

During the year, the effective implementation of hazardous waste management strategies led to a decrease in the amount of hazardous waste generated in 2021. The Group has set comprehensive reduction target by 10% reduction in hazardous waste generation by 2025.

The hazardous wastes generated by the Group during the reporting period are as follows:

The Group has put effort on waste-free initiatives in reducing non-hazardous waste. The Group has launched waste recycling and implemented different measures to reduce the wastes generated in the office. For example, used paper and plastic materials are collected in the office for recycling purpose. Waste electrical and electronic equipment is separately collected. With these measures, the Group hopes to ease the pressure on landfill space and bring benefits to the environment. The amount of non-hazardous waste generated in 2021 remained stable. The Group has set comprehensive reduction target by 10% reduction in non-hazardous waste generation by 2025.

Wastewater

The terminal and warehouse areas are equipped with drainage system to collect wastewater. Impermeable layers are applied to all pipes and treatment facilities to avoid leakage of wastewater. Rainwater and wastewater are collected by two separate systems to prevent pollution to groundwater.

The Group also cooperated with the Environment Faculty of South China University of Technology (華南理工大學環境學院) to develop a sewage treatment facility, which treats wastewater with microorganisms. During this year, around 4,980.00 m³ (2020: 17,479.70 m³) of wastewater was discharged and treated. After the treatment, the water which meets satisfactory quality standard, is used in fire services and planting. Not only the emission of wastewater to land and water bodies is reduced, but also the water can be reused to save the water resource. This system is simple and the cost of maintenance and operation is low. Therefore, it is widely admired and accepted by government departments and peers.

Noise

Noise is mainly generated from the operations of blower of boilers, pumps and compressors, etc. Appropriate acoustic insulation is applied to those machines. Regular maintenance is also conducted as to reduce the noise generated due to wearing of the components in those machines.

A2. USE OF RESOURCES

The Group has adopted policies and guidelines to improve the efficiency in energy, water and other material consumption, including "Energy Saving Management System".

Energy

The energy consumption of the Group mainly comes from fossil fuels and electricity. The Group promotes the idea of "green office" to reduce the electricity consumption as follows:

- The temperature in the office is set at 26 Degree Celsius in summer.
- No heating is supplied in winter according to the characteristic of weather in South China.

A2. 資源使用

本集團已採納政策及指引提升能源、 水及其他物料的消耗效益,包括「節 能管理系統」。

能源

本集團能源消耗主要來自化石燃料及 電力。本集團推廣「綠色辦公室」概 念,以減低電力消耗,詳情如下:

- 夏天時辦公室的溫度設定為攝氏 26度。
- 根據華南地區天氣的特點,冬天 不會提供暖氣。

- All electronic appliances have to be switched off when leaving the office.
- After all staff leave the office, security guards double check the electronic appliances and ensure all of them are switched off.

The Group also checks the oil usage frequently to minimise the chances of oil leakage which lead to energy wastage.

In light of using the gasoline recovery device, the volatilized gasoline was collected and re-transformed to gasoline for the terminal storage business, resulting in the purchased electricity consumption increased in 2021. The decrease in both petrol and diesel consumption in 2021 was mainly attributable to the reduction in business travels and transportation by vehicles, as well as effective implementation of fuel saving strategies by our terminals during the year. The Group has set inclusive total energy consumption reduction target by 10% by 2025. During the year, the energy consumptions are as follows:

Water

Water is another important resource used for the daily operation. In order to monitor the usage of water, meters are installed in different locations and water consumption is recorded regularly. Staff are responsible for managing the water usage and checking the water system. If leakage of water pipe happens, repair will be immediately carried out to reduce the wastage of water resource.

In the workplace, the water pressure is adjusted according to the actual water usage. To encourage water-saving, water usage of each staff in the staff quarter is recorded and the staff has to pay water bills by themselves. Owing to the times of cleaning the storage tanks increased for the terminal storage business, the water consumption increased in 2021. The Group has set a reduction target of 10% in water consumption by 2025. The water consumption during the reporting period is as follow:

Nitrogen

Nitrogen is an important resource for facilitating the storage of highly volatile substances. It provides a protective layer of gas on the substances, which is named as blanketing. The process is controlled automatically instead of manually to avoid wastes. The usage of nitrogen is monitored to ensure there is no leakage.

A3. THE ENVIRONMENT AND NATURAL RESOURCES

The Group's terminal is near to the waterbody with high biodiversity and rich fisheries resources. Based on the Group's internal policies, efforts have been made to minimise the impact of activities on the environment. For example, two sets of oil spill monitoring and alerting system have been installed in the water body near the terminal. The system is able to detect oil spill accidents occurred when the oil tanker is berthing or oil products are loaded.

Our terminals are also monitored by staff under 24-hour realtime video surveillance system. If oil spill accidents are detected, the signal from the alarm system can reach the responsible staff and prompt remedies can be carried out to reduce the impact on the environment.

To strength the pollution control, the Group has cooperated with a company specialised in handling oil spill accidents to equip adequate facilities (e.g., oil boom) to prevent the spread of oil leakage in the sea.

A4. CLIMATE CHANGE

Governance

Our group addresses climate-related risks based on the nature of the risk to our operations. The physical impacts of climate change, including extreme weather events, or damage to facilities have immediate operational impacts and are treated as operational risks. Long-term challenges, such as emerging ESG issues and climate-related risks and opportunities, may be discussed by the Group's ESG Working Group.

Supported by our ESG Working Group, our Board oversees climate-related issues and risks regularly during board meetings and ensures that they are incorporated into our strategy.

A3. 環境及天然資源

本集團的碼頭鄰近水域,生態多樣性 甚高及魚類資源豐富。根據本集團的 內部政策,已致力減低業務活動對環 境的影響。舉例而言,鄰近碼頭的水 域已安裝兩組漏油監察及警報系統。 在油輪靠岸或卸載油品時,系統能偵 測是否發生漏油意外。

員工亦會以24小時實時錄像監視系統 監察碼頭。倘發生漏油意外,警報系 統會傳達訊號予負責員工,並採取迅 速補救措施,降低對環境之影響。

為加強污染監控,本集團與專門處理 漏油意外的公司合作,以配備充分設施(如攔油索),避免海上漏油擴散。

A4. 氣候變化

管治

本集團按營運風險的性質來處理氣候相關的風險。氣候變化包括極端天氣事件的實際影響,或設施遭到破壞會即時影響營運,並視為營運風險處理。本集團的環境、社會及管治工作小組會討論長遠挑戰,比如新出現的環境、社會及管治事宜、與氣候相關的風險及機遇。

在環境、社會及管治工作小組的支持下,董事會在董事會會議上定期監督 與氣候有關的事宜及風險,並確保其 被納入我們的策略。 To ensure our Board to keep up with the latest trend of climate-related issues, climate competence training will be provided to ensure it has the necessary expertise and skills to oversee the management of climate-related issues. Our Board also seeks professional advice from external experts when necessary to better support the decision-making process.

Our ESG Working Group provides effective governance for integrating and addressing ESG issues, including climate change, within our business. The ESG Working Group is responsible for approving operational emissions targets for the Group and commissioning an ESG benchmarking, as well as gap analysis exercise to identify gaps in both disclosure and policy relative to the best practice standards. Moreover, the ESG Working Group works closely with the Group's different operation departments, with an aim to develop consistent and enhanced approaches on addressing ESG risk issues and report to the management.

Strategy

Climate change risk forms part of our overall risk profile through its role in increasing the frequency and intensity of certain diseases, and the health and mortality impacts resulting from natural disasters. We assess the overall level of risk by taking into consideration a range of diverse risk factors across the many categories in our services range. This diversity of risk is combined with our business strategy and broad geographic footprint helps us mitigate risk and provide protection against the impacts of short-term climate change effects.

Our products and services continue to provide protection for people in our communities against weather and heat-related disease. Besides, we continue to explore opportunities to engage our business partners and encourage them to develop climate resilience and reduce their operational carbon footprint by taking into consideration of different climate-related scenarios, including a "2°C or lower scenario" through the following steps:

策略

由於氣候變化風險,對部分疾病發生的頻密和劇烈程度加劇,加上天災對健康和人命的影響,氣候變化風險屬本集團整體風險概況的一部分。評估整體風險水平時,本集團會考慮到旗下服務類別中各項不同的風險因素,不同的風險與我們業務對策相結會不同的風險與我們業務對策相結輕極,在抵禦短期的氣候變化帶來保護。

本集團的產品和服務繼續為區內人民 提供保護,使他們免受氣候和熱病相 關之苦。此外,我們繼續探索機會, 委託和鼓勵業務夥伴開發適應氣候的 能力,並透過以下步驟,考慮不同氣 候相關情景,包括「攝氏2度或以下情 景」,減少彼等在運作時的碳排放量:

Step 1: Set Future Images Assuming Climate Change Effects

As climate change measures proceeds, there is a possibility that the industry will be exposed to substantial changes, such as stricter policies including the introduction of and increases in carbon pricing, as well as advances in technology and changes in customer awareness.

In light of these climate change effects, based on the International Energy Agency ("IEA") scenarios and others, we developed multiple future images as the external environment that will surround our Group. With regard to the IEA scenarios, we put focus on the 2°C scenario (2DS) and pictured future images in case where climate change measures do not progress and where such measures progress further "Beyond 2°C scenario".

Step 2: Consider the Impacts

We considered the impacts on our Group for each of the future images developed in Step 1. We believe that in such a society, it will be possible to expand carbon dioxide reduction effects.

With regard to effects on raw material procurement and production, introduction of and increases in carbon pricing is anticipated in accordance with the global advance of climate change measures, leading to the possibility of higher raw material procurement and production costs.

On the other hand, in the case where climate change measures are not adequate throughout society, production interruptions and supply chain disruptions are likely to increase as a result of higher frequency and intensification of natural disasters such as flooding.

步驟1:制定假設氣候變化的未來圖像

隨著氣候變化措施的運行,業界可能面對 以下劇變,比如更為嚴謹的政策(包括引入 和調高碳定價),以及科技日新月異和客戶 認知的變化。

鑒於氣候變化的影響,按照國際能源署 (「國際能源署」)的情境及其他因素,我們 已建立多個未來圖像,作為環繞本集團的 外部環境。就國際能源署的情境而言,我 們聚焦於攝氏2度情境(2DS)。即使氣候變 化措施並無進展及相關進展遠超「越過攝氏 2度的情景」,我們亦已描繪將來圖像。

步驟2:考慮影響

我們考慮按步驟1建立的未來圖像對本集團 的影響。我們認為在社區下,有可能擴大 減少二氧化碳排放的影響。

就採購原材料和生產而言,因應全球對氣 候變化的措施日趨完善,可以預料會引入 和調高碳價格,以致原材料採購與生產成 本向上。

另一方面,假若社會上並無設有完備的氣候變化措施,天災(如水災)發生的次數與程度將會加劇,使生產受到干擾和供應鏈中斷。

Step 3: Respond to the Strategies

Our Group will begin promoting the reduction of non-renewable energy in our daily operation. This strategy will allow for flexible and strategic responses to each demand for the regions where the emission factors of purchased electricity consumptions are high. By promoting real carbon emissions reductions throughout the world through comprehensive energy-saving policies and introduction of renewable energy, we are working to achieve zero carbon emission in our business.

We minimize carbon emissions through comprehensive energysaving and introduction of renewable energy. With respect to renewable energy in particular, we have set a new target, achieve a reduction rate for purchased electricity in coming few years.

With regard to the ongoing confirmation of the suitability and progress of the Group's strategies, we believe that we will have opportunities for stable funding and sustainable increases in corporate value through appropriate information disclosure, dialogue with institutional investors and other stakeholders.

Risk Management

Our Group identifies the climate change related risks or to test the existing risk management strategies under climate change with the aid of risk assessment. Hence, the areas where new strategies are needed could be identified.

The risk assessment takes a standard risk-based approach using national data, local information and expert knowledge, which can identify how climate change may compound existing risks or create new ones. The risk assessment is conducted through the following steps:

Step 1: Establish the context

- Objective/goal
- Scale
- Time frame
- Climate change scenario for most climate variables and sea level

步驟3:應對策略

本集團將從在日常營運中,開始提倡減少使用不可再生能源。透過這策略,對要求消耗購買電力引致排放因數較高的地區, 更能靈活和具策略應對。通過推行全面節 能政策及引入可再生能源,在全球提倡碳 減排,本集團致力在業務上達到零碳排放。

透過全面節能和引入使用再生能源來減低 碳排放量。尤其是在再生能源課題上,我 們已定下目標,在未來數年縮減購買電力 的比例。

對於持續確定本集團策略的適當性及進展,我們認為通過適當的資料披露,與機構投資者和其他權益人展開對話,我們有機會獲得穩定的基金,企業價值可持續向上。

風險管理

本集團在風險評估的協助下,辨別氣候變 化的相關風險或在氣候變化下,測試現有 風險管理策略。故此,我們可能識別不同 範疇內所需的新策略。

風險評估採用以風險為基礎的標準方法, 應用國家數據、地方資料和專家知識,能 夠識別氣候變化如何加重當前風險或造成 另一新風險。風險評估按以下步驟實行:

步驟1:建立情境

- 宗旨/目標
- 規模
- 時間框架
- 為多項氣候可變因素和海平面建立氣 候變化情境

Step 2: Identify existing risk (past and current)

- Identify the record of occurrence of climatic hazard in the past in the area
- Risk management strategies in place to tackle future occurrence of the hazard

Step 3: Identify future risk and opportunities

- Explore climate change projections for the selected time frame(s) and emission scenario(s)
- Identify potential hazards
- Investigate whether any existing risk from Step 2 may get worse under future projected changes
- Identify new risks that can emerge under future projected changes

Step 4: Analyse and evaluate risk

• Identify a set of decision areas or systems (i.e., geographical areas, business operation, assets, ecosystems, etc.) that has the potential to be at risk in future

As outlined within the Governance section above, the Group has robust risk management and business planning processes that are overseen by the board of directors in order to identify, assess and manage climate-related risks. The Group engages with government and other appropriate organizations in order to keep abreast of expected and potential regulatory and/or fiscal changes.

We continue to raise awareness of climate change in regard to monitoring of carbon and energy footprint in our daily operation. However, there remains gaps in understanding how such climate risks and opportunities may impact our operations, assets and profits. Our Group assesses how the business addresses climate change risks and opportunities and takes the initiative to monitor and reduce their environmental footprint.

我們繼續提升對氣候變化的認知,並於日常業務中監測碳和能源排放。然而,氣候 風險與機遇如何影響本集團的營運、資產 和盈利的理解仍存在差距。本集團評估業 務如何應對氣候變化的風險和機遇,並主 動監測和減少對環境的影響。

Metrics and Targets

Our Group adopts the key metrics to assess and manage climate-related risks and opportunities. The energy consumption and greenhouse gas (GHG) emissions indicators are the key metrics used to assess and manage relevant climate-related risks where we consider such information is material and crucial for evaluating the impact of our operation on global climate change during the year. Our Group regularly tracks our energy consumption and GHG emissions indicators to assess the effectiveness of emission reduction initiatives, as well as set targets to contribute our effort to have minimal impact on global warming.

The details of time frames over which the target applies and base year from which progress is measured are described in the section A1: "Emissions" and section A2: "Use of Resources" of this Report. Our Group adopts absolute target to manage climate-related risks, opportunities and performance.

B. SOCIAL ASPECTS

EMPLOYMENT AND LABOUR PRACTICES

The Group highly considers employees as important assets and is committed to improve in these four areas: employment, health and safety, development and training and labour standard.

指標及目標

本集團採用關鍵指標來評估及管理與氣候相關的風險及和機遇。能源消耗及溫室氣體排放指標是用於評估及管理與氣候相關的風險的關鍵指標,我們認為該等資訊對於評估我們的營運於年內對全球氣候變化的影響是重要和關鍵的。本集團盡力定期追蹤能源消耗及溫室氣體排放指標,以評估減排措施的有效性,並設定目標,致力將造成全球暖化的影響降至最低。

目標所用的時間框架及測量進度的基準年度詳情載於本報告A1:「排放」及A2:「資源使用」各節載述。本集團採取絕對目標來管理與氣候相關的風險、機遇及業績表現。

B. 社會層面

僱傭及勞工常規

本集團非常認同僱員是重要的資產, 並盡力改善以下四大範疇:僱傭、健 康與安全、發展及培訓和勞工準則。

B1. EMPLOYMENT

The Group has established and implemented a set of human resources management policies and procedures in place with the aim to provide good and safe working environment to its staff in order to comply with "Labour Contract Law of the People's Republic of China". It sets out the Group's standards for staff recruitment, promotion guidelines, remuneration scale, holiday and statutory paid leaves, parental leaves and working hours.

All employees are treated equally and their employment, remuneration and promotion opportunities will not be affected by their nationality, race, age, religion and marital status.

The Group also advocates harmonious and work-life balance culture among the employees through organising diversified activities, including annual dinner, annual gathering, sport days and birthday parties, etc. These activities can help the employees to relax and enhance communications among them. During the reporting period, no concluded case (2020: nil) regarding employment was brought against the us or our employees.

As at 31 December 2021 and 31 December 2020, the employee compositions (in percentage of employees) by gender, age group, geographical region, employment category and mode were as follows:

B1. 僱傭

B2. HEALTH AND SAFETY

Upholding the belief that safety is the first priority, the Group is committed to providing a healthy and safe workplace for all its employees and the community. The Group has established "Health, Safety and Environment Policy Statement" in accordance with the requirement of "Occupational Health and Safety Management System" (OHSAS18001) and ISO45001:2018. The Group continues to improve the working conditions and monitor the effectiveness of safety related controls. The Group complies with related health and safety laws and regulations such as "Law of the People's Republic of China on the Prevention and Control of Occupational Diseases", "Production Safety Law of the People's Republic of China", "Provisions on the Supervision and Administration of Occupational Health at Work Sites", etc. In 2021, no concluded case (2019: 1 case, 2020: nil) regarding health and safety was brought against us or our employees.

Care to Employees

Every employee is required to have a medical check annually. Employees are provided with safety training and personal protective equipment (helmet, goggles, masks, etc.) in the workplace. Occupation hazards assessment is conducted by third party regularly to monitor the performance on occupational safety. To ensure the staff to have better health protection, the Group provides medical insurance for the staff annually.

B2. 健康與安全

本集團堅守安全至上的信念, 致力 為其所有僱員及社區提供健康與 全的工作環境。本集團已根據「職業 健康安全管理體系」(OHSAS18001)及 ISO45001:2018制定「健康、安全及 環境政策聲明」。本集團不斷改改 作環境,以及監察安全相關監控的和 文性。本集團遵守《中華人民共和國 職業病防治法》、《中華人民共和國安 全生產法》及《工作場所職業衛生監督管理規定》等相關健康與安全法律 及法規。二零二一年並無(二等一九 年:一宗;二零二零年:無)針我 們或我們僱員的已完結健康與安全相 關案件。

關懷僱員

各僱員須每年進行醫務檢查。本集團 在工場為僱員提供安全培訓及個人保 護設備(頭盔、護目鏡、口罩等)。協 力廠商會定期進行職業危險評估,以 監察職業安全表現。為保證員工有更 佳健康保障,本集團每年均為員工提 供醫療保險。 The Group is committed to providing all employees with a warm and comfortable working and living environment. The Group has set up self-managed staff quarters and canteens with a view to providing sound rest space and healthy catering to its employees. Drinks are also freely provided to all employees in hot season to prevent them from having heat stroke. Furthermore, the Group offers various activities for the staff, such as annual trip, annual gathering and birthday meal, to advocate the work-life balance and harmony. Such activities can strengthen the relationships between the staffs and allow them to be more relaxed.

The Group promotes the implementation of an employee-caring scheme, "Global support for individual suffer scheme" (「一方有難,八方支援」計劃), which encourages all staff to make voluntary donation to any individual employee who has suffered serious illness or disease. During the year, an employee in need has received a donation of RMB18,166 through this scheme.

Safety Precaution in Workplace

Safety of employees in workplace is crucial. Key safety precautions are implemented as follows:

- Toxic gas detector, audible and visual alarm and emergency cut-off valve are installed in each berth.
- Parameters of all flammable and explosive substances are carefully and closely monitored (e.g., temperature, pressure, flow volume) during transfer. All parameters information is transferred to PLC (Programmable Logic Controllers) in the terminal control centre for monitoring the frontline operation.
- Worker, who enters the tank, must wear protective clothes and make sure that the toxic gas concentration does not exceed the acceptable level.
- Emergency shower, eyewash facilities and breathing apparatus are provided.

During the year, there were 2 work injury cases (2020: nil, 2019: nil) and 246 lost days (2020: nil, 2019: nil) due to minor injuries during business operations. There was no work-related fatality case (2020: nil, 2019: nil) during the year. Employees were given paid sick leave for their recovery. Overall, no employees had serious accident during the reporting period.

本集團推動實施員工關懷計劃一「一方有難,八方支援」計劃,鼓勵全體員工自願捐款給身患重疾的員工。年內,一名有困難的員工通過該計劃獲得人民幣18,166元的捐款。

工場的安全措施

僱員在工場的安全至為重要。本集團 已實施下列主要安全措施:

- 每個區域均有安裝毒氣探測機、 聲光警報及緊急斷流閥。
- 搬運時會小心密切監察所有易燃及爆炸性物質的參數(例如溫度、壓力、流量)。所有參數資料均會傳送至終端控制中心的可編程式控制器,以便監察前線營運。
- 任何工作人員進入貯存罐均須配 戴保護性衣物,並確保毒氣的濃 度不超過可接受水準。
- 提供緊急灑水、洗眼設備及呼吸 儀器。

年內,有2宗工傷個案(二零二零年: 無;二零一九年:無),損失246個 工作日(二零二零年:無;二零一九 年:無)屬業務營運中的輕微受傷。 年內並無因工死亡個案(二零二零 年:無;二零一九年:無)。僱員在 康復期間獲有薪病假。整體而言,於 報告期內,概無僱員發生重大事故。

B3. DEVELOPMENT AND TRAINING

The Group continues to provide comprehensive and suitable trainings to employees to promote a learning culture based on the Group's "Training Management Procedure" and other related internal policies. The Group analyses the employees' training and operation needs to prepare training and budget plan yearly. The Group provides diversified on-the-job trainings to employees, particularly safety trainings, with the aim to improve the quality of the employees' safety and to establish a corporate safety culture.

Generally, there are both internal and external trainings for employees. Every new employee needs to receive a three-month training including general knowledge and skills about storage tanks. Assessment is conducted after the training. Only the new employees who pass the assessment can start their work in their position. Continuous assessment is conducted to keep track on the performance of the current employees. The Group also offers on-the-job training, which based on the operation needs and annual training plan. It aims to enhance the performance and skill of employees. External training mainly includes certification training for specialists (e.g. safety management personnel, engineers, accountants, etc.). The Group invites related government departments and institutions to deliver training to ensure employees can perform duties with relevant qualifications.

With continuous trainings and assessments, the safety knowledge of the employees can be strengthened and the safety awareness can be enhanced. This can decrease the occurrence of work-related accidents.

During the reporting period, the percentage of employees received training by gender and employment category was as follows:

B4. LABOUR STANDARDS

The Group respects the human rights of employees, especially gender equality and is strongly against employment of child labour and forced labour. The Group strictly complies with "Labour Law of the People's Republic of China", Employment Ordinance of Hong Kong and other relevant laws and regulations. Recruitment guideline clearly states that person under 16 is not allowed to work in the Group and zero tolerance to child labour and forced labour.

During the year, the Group was not subject to any punishment by the government and was not involved in any lawsuit related to child labour or forced labour.

B4. 勞工準則

本集團尊重僱員的人權,特別是性別平等,且強烈反對僱用童工及強制勞工。本集團嚴格遵守《中華人民共和國勞工法》、香港僱傭條例及其他相關法律及法規。招聘指引清楚列明16歲以下人士不得在本集團工作,且絕不容忍童工及強制勞工。

本集團於本年度並無被政府施加任何 處分,且亦無牽涉任何有關童工或強 制勞工的訴訟。

OPERATING PRACTICES

B5. SUPPLY CHAIN MANAGEMENT

During the reporting period, the Group had 40 suppliers (2020: 74 suppliers) which were located in the PRC. The Group depends on suppliers to provide materials and components for different storage facilities. The selection of suppliers is based on a list of criteria, including compliance, price, quality, stability of supply and after-sales services with completion of "Supplier Assessment Form" in accordance with the Group's internal policy "Material Procurement Management Regulations". Besides, the Group assesses the suppliers with a rating system. The Group maintains a long-term relationship with suppliers based on the result from supplier assessment. During the year, the assessment result was satisfactory and there was no significant risk related to supply chain in environmental and social aspects.

The Group implements the "Organizational Risk Management Procedures" and "Organizational Environment and Relevant Management Procedures" to identify the environmental and social risks in each section of the supply chain, and determines the significant impacts of the supply chain to the environment and society with the execution of the Group's internal policies "Material Procurement Management Regulations" and the "Supplier Management Procedures". It is expected that the risk of supply chain comprises of delay, termination and accumulation of the supply of materials. The supply chain risk assessment is carried out by the managers and supervisors from the Procurement Department half-yearly. During the reporting period, there was no non-compliance case of the supplier being discovered.

To reduce the impacts of the Group's operation to the environment, the Group used to promote environmentally preferable products and services when selecting suppliers. The Group implements the "Material Procurement Management Regulations" during procurement, and requires the suppliers to be certified with the quality management systems, such as ISO9000 or equivalent. Products with the certification of environmental labelling would be more preferrable. Besides, suppliers are required to conduct sampling test and inspection for the products and services.

營運慣例

B5. 供應鏈管理

本集團實施「組織風險管理程式」及「組織環境及相關管理程式」,以識別於供應鏈各部份的環境及社會風險,並執行本集團內部政策「材料採購管理規例」及「供應商管理程序」,釐完與大應鏈對環境及社會的重大影響。預計供應鏈風險包括延誤、終止及限積材料供應。供應鏈風險評估由採購部門的經理及主管每半年進行一次。不知時期間,並無發現任何供應商不合規案例。

為減少本集團營運對環境的影響,本 集團於挑選供應商時曾推廣環保型產 品和服務。本集團於採購時實施「材 料採購管理規例」,並要求供應商通 過ISO9000等品質管制體系認證或同 等的認證。有環保標籤認證的產品會 更受歡迎。此外,供應商被要求就產 品和服務進行抽樣測試及檢查。

B6. PRODUCT RESPONSIBILITY

As a leading midstream player in providing storage service for chemical products in South China, maintaining the safety and quality of customers' products in the warehouse is the utmost concern of the Group. In order to continuously improve the quality of service provided by the Group, we have set up an internal policy – "Hazardous chemical storage Management Procedures" and other related procedures in accordance with the requirement of quality management system (ISO9001). During the year, the Group was not subject to any disputes relating to the storage service or punishment by the government and was not involved in any lawsuit related to product responsibility.

Complaints Handling

The Group upholds the feedback from the customers. The Group implements the internal policy "Customers Complaint and Services Management Procedures" to handle the complaints from the customers. Department of commerce of the Group is responsible for dealing the with complaints from customers. Prompt response will be taken and the problem will be identified to prevent similar complaints from happening. During the year, one complaint (2020: 1) related to the efficiency of goods unloading was received by the Group.

The Group responded to the cases immediately and explained to the clients. The situation has improved after the adjustment of the working schedule of employees and the increase in the consumer service training.

B6. 產品責任

作為於華南提供化學產品貯存服務的領先中游從業者,保持倉庫內客戶產品的安全及質量是本集團第一要務。為持續改善本集團提供的服務質量,我們已根據質量管理系統(ISO9001)制定內部政策一「危險化學倉儲管理程式」及其他相關程式。年內,本集團並未面臨任何有關倉儲服務的糾紛或受到政府懲處,亦無牽涉任何產品責任相關訴訟。

投訴處理

本集團重視客戶的意見回饋。本集團實施內部政策「客戶投訴及服務管理程序」,以處理客戶的投訴。本集團的商務部門負責處理客戶投訴。該部門會採取迅速反應,並識別問題所在,避免類似投訴出現。年內,本集團接獲一宗有關卸貨效率的投訴(二零二零年:一宗)。

本集團即時回應有關投訴並向客戶解 釋情況。調整僱員工作時間表及增加 消費者服務培訓後,有關情況已得到 改善。

Quality Control

According to "Regulations on the Safety Administration of Dangerous Chemicals", the Group requires customers to provide Material Safety Data Sheet (MSDS) for chemicals stored. Besides, all storage tanks are labelled with UN Number (United Nation Number) and other relevant numbers for identification.

When customers' goods are delivered to the tank, the testing company engaged by the customers will carry out sample testing on the goods, verify the certification or testing report provided by the suppliers and check if the name, specification and technical information of the sample meet the national/international standards. Only goods that pass the testing and meet the related requirements can be stored in the Group's warehouse.

Customer Information Protection

The Group upholds a belief that information security and privacy is the key principle for operation. We comply with relevant laws and regulations. According to Group's Staff Handbook, employees are required to sign an agreement to protect the privacy of clients and any other sensitive business information. Employees who violate the agreement will receive punishment and legal action will be taken. During the year, no severe violation was found that posed a significant impact on the Group.

B7. ANTI-CORRUPTION

The Group maintains a high standard of business integrity throughout its operations and tolerates no corruption or bribery in any form, the Group strictly complies with the "Chapter III – Crimes of Undermining the Order of Socialist Market Economy Criminal Law of the People's Republic of China", "Chapter VIII – Graft and Bribery of Criminal Law of the People's Republic of China", "Prevention of Bribery Ordinance in HKSAR" and other relevant laws and regulations relating to anti-corruption.

質量控制

根據《危險化學品安全管理條例》,本 集團要求客戶就所貯存化學品提交 《物料安全資料表》。除此之外,所有 貯存罐均貼有編號(聯合國編號)及其 他相關編號,以供識別。

當客戶貨品交付至存儲罐時,客戶委聘的檢驗公司將對貨品進行抽樣測試、核實認證或測試供應商提供的報告及檢查樣品名稱、規格及技術資料是否達到國內/國際標準。只有通過檢測及達到相關要求的貨品可儲存於本集團倉庫。

客戶資料保障

資訊安全及隱私是對營運至關重要的 原則,此乃本集團秉承的理念。我們 遵守相關法律及法規。根據本集團的 員工手冊,僱員須簽立協議以保護客 戶隱私及任何其他敏感的商業資料。 違反協議的僱員將遭懲處,並會採取 法律行動。年內,概無發現對本集團 造成重大影響的嚴重違規事項。

B7. 反貪污

本集團於整個營運過程貫徹高標準的 行商操守,不姑息任何形式的腐敗或 賄賂,本集團嚴格遵守中華人民共和 國刑法《第三章一破壞社會主義經濟 秩序罪》、中華人民共和國刑法《第八 章一貪污賄賂罪》、香港特別行政區 《防止賄賂條例》及其他有關反貪腐的 相關法律及法規。 The Group has adopted "Compliance Policies" and stated that the Group takes reasonable care to ensure that it will not export, re-export, or otherwise divert customer's products and other items in violation of any Trade Control Laws. All the employees and external drivers who can get access to the customers' products are monitored. For example, the weight of truck is checked when it enters and leaves the premises to monitor any abnormal loading.

The Group has established related investigation and whistle-blowing procedure for any corruption cases. The Group has zero tolerance to any forms and degrees of bribery or corruption behaviours in relation to the Group's business activities. During the year, no concluded case (2020: nil) regarding corrupt practices was brought against us or our employees.

The Group provided training sessions comprising of anti-corruption, anti-bribery, anti-fraud, anti-blackmail and anti-laundering to the directors and staff regularly. During the year, 98% (2020: 96%) of the employees received the anti-corruption training.

OPINION

We have audited the consolidated financial statements of Hans Energy Company Limited and its subsidiaries ("the Group") set out on pages 103 to 219, which comprise the consolidated balance sheet as at 31 December 2021, the consolidated income statement, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated cash flow statement for the year then ended and notes to the consolidated financial statements, including a summary of significant accounting policies.

Notes to the Financial Statements

1 SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain amendments to HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 1(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting periods reflected in these financial statements.

(b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 December 2021 comprise the Company and its subsidiaries (together referred to as the "Group") and the Group's interest in an associate and a joint venture.

The measurement basis used in the preparation of the financial statements is the historical cost basis except that other investments (see note 1(g)) are stated at their fair value.

Non-current assets are stated at the lower of carrying amount and fair value less costs to sell.

(a) 合規聲明

編製財務報表所採用之計算基準 為歷史成本基準,惟按公允值列 賬的其他投資(見附註1(q))除外。

(b) Basis of preparation of the financial statements (continued)

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 2.

(c) Changes in accounting policies

The HKICPA has issued certain amendments to HKFRSs that are first effective for the current accounting period of the Group. None of these developments has had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented in these financial statements.

The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

(b) 財務報表之編製基準(續)

本公司持續對估計及相關假設進 行檢討。如果會計估計之更改 僅影響該期間,則有關影響在估 計變更期間確認,或如果有關更 改影響本期間及未來期間,則有 關影響於更改期間及未來期間確 認。

附註2論述管理層在應用對財務 報表有重大影響的香港財務報告 準則時所作的判斷及估計的不確 定性的主要來源。

(c) 會計政策變動

香港會計師公會已頒佈若干對香港財務報告準則的修訂,在本集團的當前會計期間首次生效。該等發展並無對本集團現時或過往期間的業績及財務狀況的編製方式或於該等財務報表中的呈現方式產生重大影響。

本集團並無應用任何尚未於本會計期間生效之新訂準則或詮釋。

(d) Subsidiaries, controlled structured entities and noncontrolling interests

Subsidiaries are entities (including structured entities) controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

A structured entity is an entity that has been designed so that voting or similar rights are not the dominant factor in deciding who controls the entity, such as when any voting rights relate to administrative tasks only and the relevant activities are directed by means of contractual arrangements.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

(d) 附屬公司、受控制結構性實體及 非控股權益

附屬公司乃受本集團控制之實體 (包括結構性實體)。當本集團承 受或享有參與實體所得的可變回 報,且有能力透過其對實體的權 力影響該等回報時,則本集團控 制該實體。於評估本集團是否擁 有權力時,僅會考慮其實質權利 (由本集團及其他方持有)。

結構性實體指實體經過設計使投票表決權或類似權利不能作為主 導因素決定誰實質控制實體,例如當任何投票表決權僅與行政管理活動有關,相關的業務活動應 當透過合同安排開展。

Non-controlling interests are presented in the consolidated balance sheet within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated income statement and the consolidated statement of comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company. Loans from holders of non-controlling interests and other contractual obligations towards these holders are presented as financial liabilities in the consolidated balance sheet in accordance with notes 1(q) or (t) depending on the nature of the liability.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

In the Company's balance sheet, an investment in a subsidiary is stated at cost less impairment losses (see note 1(I)). A controlled structured entity that is directly held by the Company is considered as branch/agent of the Company and the assets and liabilities thereof are accounted for as assets and liabilities of the Company in the Company's balance sheet.

(d) 附屬公司、受控制結構性實體及 非控股權益(續)

非控股權益在綜合資產負債表之權益項目中與本公司股東應佔權益分開列示。本集團業績之非控股權益在綜合損益表及綜合全通收益表呈列以顯示本年度之溢利或虧損總額和全面收益總額於非控股權益與本公司股東之間之分配。來自非控股權益持有人之其他合約性有款及該等持有人之其他合約性負減(q)就綜合資產負債表呈列為財務負債。

本集團就並無導致失去附屬公司 控制權的變動按權益交易入賬, 並對綜合權益中控股及非控股權 益的數額作出調整,以表明相關 權益變動,但並未對商譽作出調 整,且並未確認收益或虧損。

(e) Associates and joint ventures

An associate is an entity in which the Group or Company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

A joint venture is an arrangement whereby the Group or Company and other parties contractually agree to share control of the arrangement, and have rights to the net assets of the arrangement.

An investment in an associate or a joint venture is accounted for in the consolidated financial statements under the equity method, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). The cost of the investment includes purchase price, other costs directly attributable to the acquisition of the investment, and any direct investment into the associate or joint venture that forms part of the Group's equity investment. Thereafter, the investment is adjusted for the post-acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment (see notes 1(f) and (l)(ii)). At each reporting date, the Group assesses whether there is any objective evidence that the investment is impaired. Any acquisition-date excess over cost, the Group's share of the post-acquisition, post-tax results of the investees and any impairment losses for the year are recognised in the consolidated statement of profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised in the consolidated statement of profit or loss and other comprehensive income.

(e) 聯營公司及合營企業

聯營公司指本集團或本公司對其 管理層具有重大影響力(包括參 與財務及經營政策決策)但並非 控制或共同控制的實體。

合營企業是指本集團或本公司及 其他各方以合約方式約定分享對 該安排的控制權的安排,並擁有 該安排的淨資產的權利。

於聯營公司或合營企業的投資乃 使用權益法於綜合財務報表入 賬,除非其分類為持作出售(或 包括在分類為持作出售的出售組 別)。根據權益法,投資最初按 成本列賬,並按本集團應佔被投 資方可識別資產淨值於收購日期 的公允值超過投資成本(如有)的 部分進行調整。投資成本包括購 買價,直接歸屬於收購投資的其 他成本,以及作為本集團股權投 資一部分的對聯營公司或合營企 業的任何直接投資(見附註1(f)及 (I)(ii))。其後,投資將根據本集 團應佔被投資方資產淨值的收購 後變動以及與投資相關的任何減 值損失進行調整。於各報告日 期,本集團評估是否存在任何客 觀證據表示投資已減值。任何於 收購日超過成本的部分,本集團 應佔收購被投資方後的比例,被 投資方的税後業績及當年的任何 減值虧損均於綜合損益表確認, 而本集團應佔被投資方的其他全 面收益的收購後除税後項目於綜 合損益及其他全面收益表中確 認。

(e) Associates and joint ventures (continued)

When the Group's share of losses exceeds its interest in the associate or the joint venture, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method, together with any other long-term interests that in substance form part of the Group's net investment in the associate or the joint venture, after applying the ECL model to such other long-term interests where applicable (see note 1(l)(ii)).

Unrealised profits and losses resulting from transactions between the Group and its associates and joint venture are eliminated to the extent of the Group's interest in the investee, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method.

In all other cases, when the Group ceases to have significant influence over an associate or joint control over a joint venture, it is accounted for as a disposal of the entire interest in that investee, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former investee at the date when significant influence or joint control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset (see note 1(g)).

In the Company's balance sheet, investments in associates and joint venture are stated at cost less impairment losses (see note 1(I)(ii)), unless classified as held for sale (or included in a disposal group that is classified as held for sale).

(f) Goodwill

Goodwill represents the excess of

- (i) the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interest in the acquiree and the fair value of the Group's previously held equity interest in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

When (ii) is greater than (i), then this excess is recognised immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses. Goodwill arising on a business combination is allocated to each cash-generating unit, or groups of cash generating units, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see note 1(I)(ii)).

On disposal of a cash generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

(g) Other investments in debt and equity securities

The Group's policies for investments in debt and equity securities, other than investments in subsidiaries, are set out below.

Investments in debt and equity securities are recognised/ derecognised on the date the Group commits to purchase/sell the investment. The investments are initially stated at fair value plus directly attributable transaction costs, except for those investments measured at fair value through profit or loss ("FVPL") for which transaction costs are recognised directly in profit or loss. For an explanation of how the Group determines fair value of financial instruments, see note 30(f). These investments are subsequently accounted for as follows, depending on their classification.

Changes in fair value are recognised in other comprehensive income, except for the recognition in profit or loss of expected credit losses, interest income (calculated using the effective interest method) and foreign exchange gains and losses. When the investment is derecognised, the amount accumulated in other comprehensive income is recycled from equity to profit or loss.
- FVPL if the investment does not meet the criteria for being measured at amortised cost or FVOCI (recycling). Changes in the fair value of the investment (including interest) are recognised in profit or loss.

Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained earnings. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVPL or FVOCI, are recognised in profit or loss as other income in accordance with the policy set out in note 1(v)(iv).

The cost of self-constructed items of property, plant and equipment includes the cost of materials, direct labour, the initial estimate, where relevant, of the costs of dismantling and removing the items and restoring the site on which they are located, and an appropriate proportion of production overheads and borrowing costs (see note 1(x)).

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their residual value, if any, using the straight-line method over their estimated useful lives as follows:

(ii) Construction in progress represents oil and gas station under construction and pending installation, and is stated at cost less impairment losses (see note 1(I)(ii)). Cost comprises direct costs of construction as well as interest charges, and foreign exchange differences on related borrowed funds to the extent that they are regarded as an adjustment to interest charges, during the periods of construction.

Construction in progress is transferred to property, plant and equipment when the asset is ready for its intended use. No depreciation is provided in respect of construction in progress.

(i) Investment property

Investment properties are interests in land and buildings (including the leasehold property held as right-of-use assets which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at cost less accumulated depreciation and any impairment losses (see note 1(I)(ii)).

The Group's investment property is rented out under an operating lease. The investment property is depreciated on a straight-line basis over its estimated useful life as 20–30 years. Any gains or losses on the retirement or disposal of investment properties are recognised in the statement of profit or loss in the year of the retirement or disposal.

(i) Intangible assets

Intangible assets that are acquired by the Group are stated at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses (see note 1(l)(ii)). Amortisation of club memberships is charged to profit or loss on a straight-line basis over the estimated useful lives of 17 to 24 years.

Both the period and method of amortisation are reviewed annually.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

In assessing value in use, the estimated future cash flows are discounted to their present value using the pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit). A portion of the carrying amount of a corporate asset (for example, head office building) is allocated to an individual cash-generating unit if the allocation can be done on a reasonable and consistent basis, or to the smallest group of cash-generating units if otherwise.

Under the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited, the Group is required to prepare an interim financial report in compliance with HKAS 34, Interim financial reporting, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the balance sheet date (see notes 1(I)(i) and (ii)).

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the balance sheet date to which the interim period relates.

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the weighted average cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

A contract asset is recognised when the Group recognises revenue (see note 1(v)) before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for ECL in accordance with the policy set out in note 1(l)(i) and are reclassified to receivables when the right to the consideration has become unconditional (see note 1(o)).

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue (see note 1(v)). A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 1(o)).

A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset (see note 1(n)).

Trade receivables that do not contain a significant financing component are initially measured at their transaction price. Trade receivables that contain a significant financing component and other receivables are initially measured at fair value plus transaction costs. All receivables are subsequently stated at amortised cost using the effective interest method and including allowance for credit losses (see note 1(I)(i)).

(p) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated cash flow statement. Cash and cash equivalents are assessed for ECL in accordance with the policy set out in note 1(l)(i).

(r) Employee benefits

(i) Short-term employee benefits and contributions to defined contribution retirement plans

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(ii) Share-based payments

The fair value of share options granted to employees is recognised as an employee cost with a corresponding increase in a share-based compensation reserve within equity. The fair value is measured at grant date using the binomial model, taking into account the terms and conditions upon which the options were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the options, the total estimated fair value of the share options is spread over the vesting period, taking into account the probability that the options will vest.

Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the balance sheet date, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The limited exceptions to recognition of deferred tax assets and liabilities are those temporary differences arising from the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided they are not part of a business combination), and temporary differences relating to investments in subsidiaries to the extent that, in the case of taxable differences, the Group controls the timing of the reversal and it is probable that the differences will not reverse in the foreseeable future, or in the case of deductible differences, unless it is probable that they will reverse in the future.

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the balance sheet date. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at each balance sheet date and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Additional income taxes that arise from the distribution of dividends are recognised when the liability to pay the related dividends is recognised.

- in the case of current tax assets and liabilities, the Company or the Group intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or
- in the case of deferred tax assets and liabilities, if they relate to income taxes levied by the same taxation authority on either:
 - the same taxable entity; or
 - different taxable entities, which, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered, intend to realise the current tax assets and settle the current tax liabilities on a net basis or realise and settle simultaneously.

(t) Trade and other payables

Trade and other payables (including amounts due to related parties) are initially recognised at fair value and are stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at invoice amounts.

(u) Provisions and contingent liabilities

Provisions are recognised when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Where some or all of the expenditure required to settle a provision is expected to be reimbursed by another party, a separate asset is recognised for any expected reimbursement that would be virtually certain. The amount recognised for the reimbursement is limited to the carrying amount of the provision.

(v) Revenue and other income

Income is classified by the Group as revenue when it arises from the sales of goods, the provision of services or the use by others of the Group's assets under leases in the ordinary course of the Group's business.

Revenue is recognised when control over a product or service is transferred to the customer, or the lessee has the right to use the asset, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Where the contract contains a financing component which provides a significant financing benefit to the customer for more than 12 months, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction with the customer, and interest income is accrued separately under the effective interest method. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. The Group takes advantage of the practical expedient in paragraph 63 of HKFRS 15 and does not adjust the consideration for any effects of a significant financing component if the period of financing is 12 months or less.

Further details of the Group's revenue and other income recognition policies are as follows:

(i) Rental income from operating leases

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable.

(ii) Port and transshipment income

Port and transshipment income is recognised upon performance of the services.

Revenue arising from the sales of oil and petrochemical products is recognised at the point in time when the customer has the ability to direct the use and obtain substantially all of the remaining benefits of the products, which is usually when the legal title is transferred to the customer.

(iv) Dividends

- Dividend income from unlisted investments is recognised when the shareholder's right to receive payment is established.
- Dividend income from listed investments is recognised when the share price of the investment goes ex-dividend.

(v) Interest income

Interest income is recognised as it accrues under the effective interest method using the rate exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For creditimpaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset (see note 1(I)(i)).

(vi) Government grants

Government grants are recognised in the balance sheet initially when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as income in profit or loss on a systematic basis in the same periods in which the expenses are incurred.

The functional currencies of the Company and its subsidiaries in Hong Kong are Hong Kong dollars. The functional currencies of the Company's subsidiaries in the PRC are Renminbi Yuan ("RMB"). The Group adopted Hong Kong dollars as its presentation currency.

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the balance sheet date. Exchange gains or losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the company initially recognises such non-monetary assets or liabilities. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was measured.

The results of operations with functional currency other than Hong Kong dollars are translated into Hong Kong dollars at the exchange rates approximating the exchange rates ruling at the dates of the transactions. Balance sheet items are translated into Hong Kong dollars at the closing exchange rates at the balance sheet date. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the translation reserve.

On disposal of an operation with functional currency other than Hong Kong dollars, the cumulative amount of the exchange differences relating to that operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

When indication of impairment is identified, management prepares discounted future cash flow to assess the differences between the carrying amount and value in use and provides for impairment loss. Any change in the assumptions adopted in the cash flow forecasts would increase or decrease in the provision of impairment loss and affect the Group's financial position.

The Group's investment property consists of a filling station in the PRC that was classified as property, plant and equipment in 2020. The Group leased out the filling station to an independent third party in 2021 and classified the filling station as investment property accordingly.

The investment property was stated at cost and the aggregate fair value of the Group's investment property at 31 December 2021 was approximately \$47 million (2020: \$Nil), a Level 3 fair value measurement, based on a valuation carried out by an independent qualified professional valuer not connected with the Group, using income approach taking into account the expected net operating income of the properties in the future and capitalised into the value at an appropriate capitalisation rate. The Group appoints an external valuer to conduct valuation on the Group's property, and the selection criteria include market knowledge, reputation, independence and maintenance of professional standards. The Group has adopted the cost model under HKAS 40 to account for its investment property, and accordingly, the carrying amounts of the investment property were not adjusted to the revalued amount at the year end.

The investment property is leased to third parties under operating leases, further summary details of which are included in note 31.

During the year, there were no transfers of fair value measurements between Level 1 and Level 2 and no transfers into or out of Level 3 (2020: Nil).

The Group is required to contribute a certain percentage of the salaries, bonuses and certain allowances of its staff to the retirement scheme. The only obligation of the Group with respect to the retirement benefit scheme is to make the required contribution under the scheme. The Group has no other material obligation for the payment of pension benefits associated with this scheme beyond the annual contributions described above.

The Group also operates a Mandatory Provident Fund Scheme ("the MPF scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of \$30,000. Contributions to the plan vest immediately.

The Share Award Scheme is subject to the administration of the Board in accordance with the Scheme Rules. The Board may engage one or more trustees to administer the Share Award Scheme as the Board thinks fit. The Share Award Scheme will terminate on the tenth anniversary of the Adoption Date or such earlier date as the Board may determine. The Board shall not grant any further awards if such award would cause the aggregate number of shares underlying such award and all other outstanding awards (taken together with all unvested awarded shares granted under the Scheme Rules) to exceed 5% of the number of issued shares at the date of grant. The Board may, from time to time remit funds to the trustee for the purposes of the Share Award Scheme, and such money will form part of the trust fund. The Board may instruct the trustee to purchase the number of shares underlying the award from the open market (either on-market or off-market) and the trustee shall hold such shares on trust for the participants until they are vested in accordance with the Scheme Rules.

During the year ended 31 December 2019, the Company remitted in total of \$20,000,000 to the trustee for the purchase of shares of the Company pursuant to the Share Award Scheme. On 15 April 2019, the trustee purchased a total number of 58,590,000 shares (the "Share Purchase") on the market at a total consideration of approximately \$16,581,000 for the purpose of the Share Award Scheme. As at 31 December 2020 and 2021, no grant of awards has been made under the Share Award Scheme.

The reserve is restricted to use and is not available for distribution.

(e) Capital management

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

The Group monitors its capital structure on the basis of a net debt-to-capital ratio. For this purpose the Group defines net debt as total debt (which includes interestbearing loans and borrowings), less cash and bank balances. Capital comprises all components of equity, plus net debt.

During 2021, the Group's strategy, which was unchanged from 2020, was to maintain the net debt-to-capital ratio at an appropriate level. In order to maintain or adjust the ratio, the Group will consider and may adjust the amount of dividends paid to shareholders, issue new shares, return capital to shareholders, raise new debt financing or sell assets to reduce debt.

The net debt-to-capital ratio (as define above) was 0.95 (2020: 0.82) as at 31 December 2021.

Neither the Company nor any of its subsidiaries are subject to externally imposed capital requirements.

Exposure to credit, liquidity, interest rate, currency and commodity price risk arises in the normal course of the Group's business. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade receivables and cash and bank balances.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry and country in which customers operate and therefore significant concentration of credit risk primarily arise when the Group has significant exposure to individual customers. At the balance sheet date, the Group has a certain concentration of credit risk as 97% (2020: 96%) of the total trade receivables was due from the Group's five largest customers.

Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 30-180 days from the date of billing. Debtors with balances that are more than one month past due are requested to settle all outstanding balances before any further credit is granted. Normally, the Group does not obtain collateral from customers.

Credit loss rates are assigned to the trade receivable by reference to various qualitative and quantitative factors such as market default rate of the industry in which the customer operates and the credit ratings, historical default experience and the financial position of the customer. adjusted for other factors, where applicable, to reflect the current and forward-looking information specific to the customer and on the macroeconomic conditions which might affect the customer's ability to settle the trade receivable. Under this approach, ECL of \$5,000,000 was recognised for trade receivable amounting to \$344,082,000 due from a customer of the Group for the year ended 31 December 2021. The management is of the opinion that the ECL of the remaining trade receivables of \$19,075,000 were immaterial to the Group's financial statements.

Movement in the loss allowance account in respect of trade receivables during the year is disclosed in note 20(b).

Other financial assets measured at amortised cost

Other financial assets measured at amortised cost mainly consist of other receivables. These mainly comprised of deposits and other receivables due from third parties. The Group's exposure to credit risk is influenced mainly by the individual characteristics of each debtor. In determining the ECL, the Group has taken into account the credit ratings, historical default experience and the financial position of the counterparties, adjusted for factors, where applicable, that are specific to the debtors and macroeconomic conditions of the industry in which the debtors operate, in estimating the probability of default of each of these financial assets occurring within their respective loss assessment time horizon, as well as the loss upon default in each case. During the year ended 31 December 2021, lifetime ECL of \$8,787,000 was fully recognised for other receivables due from a debtor that was in financial difficulty (2020: \$Nil).

Cash and bank balances

In respect of cash and bank balances, the Group limits its exposure to credit risk by placing deposits with financial institutions that meet the established credit rating or other criteria. Given these high credit ratings, management does not expect any counterparty to fail to meet its obligations. As at 31 December 2021, the Group has a certain concentration of credit risk as 56% of total cash and bank balances were deposited with a financial institution in Hong Kong (2020: 44%).

Individual operating entities within the Group are responsible for their own cash management, including the short-term investment of cash surpluses and the raising of loans to cover expected cash demands, subject to approval by the Company's board when the borrowings exceed certain predetermined levels of authority. The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.
